This is one of the first times that the County and the Town have joined their planning efforts to provide improved and coordinated recreation and culture services to their citizens.

## MP EGLINSKI RELINQUISHES HIS SEAT FOR THE DAY IN HONOUR OF 'DAUGHTERS OF THE VOTE'

On March 8th, to mark the 100th anniversary of the first women in Canada being allowed to vote, and in recognition of Canada's 150th birthday, one young woman from each of our country's 338 ridings took a seat in Parliament as part of the 'Daughters of the Vote' initiative.

Mikayla Bosch, from Mayert-horpe, represented our riding of Yellowhead. She was selected out of a total of 1,500 applications from across Canada. Currently

studying International Relations at the University of British Columbia, Ms. Bosch has a strong passion for pursuing a position in leadership, as well as participating in humanitarian projects and global equality.

The initiative, organized in partnership with Equal Voice, also coincided with international Women's Day. Equal Voice is a national, bilingual, multi-partisan organization dedicated to electing more women to all levels of political office in Canada. Despite the advances in political participation in Canada, women remain under-represented. To-

day, only 26 percent of elected members in the House of Commons are female.

I was pleased to meet with Ms. Bosch and be part of the effort to promote the participation of young women in elected politics. We are privileged to live in Canada, a country in which men and women are regarded as equal. I believe that every person has the right to live the life they want to lead, and it is my hope that all of our children, regardless of their gender, will have the opportunities and tools they require to become tomorrow's leaders.

# DEFERRED MAINTENANCE PROJECTS AND FUNDING

On February 27 the Alberta New Democrat government announced over \$14 Million in funding for repairs and upgrades to community housing and seniors' housing in rural Alberta. This is one of the practical ways that our government is working to make life better for rural Albertans and for seniors.

Where a written statement of opposition is filed with the Board within thirty (30) days following the publication of this notice, the Board shall forthwith order, subject to certain exceptions as noted below, that a public hearing be conducted with respect to any grounds of opposition set out in the statement, in relation to any section or part of the pipeline affected by the concerns disclosed in the written statement. The Board is not required to give any notice, hold any hearing or take any other action with respect to any written statement of opposition filed with the Board and may at any time disregard any such written statement if the person who filed the statement files a notice of withdrawal, or if it appears to the Board that the statement is frivolous, vexatious or is not made in good faith. If the Board determines it appropriate to hold a public hearing,

the Board will fix a suitable time and place for the hearing and will publish a notice of the hearing in at least one issue of a publication in general circulation within the area in which the lands acquired or proposed to be acquired are situated. The Board will also send a notice of the public hearing to each person who has filed a written statement of opposition with the Board. The public hearing will be held near to where the lands to which the statement relates are situated. The Board, or a person authorized by the Board, may make such inspection of the lands acquired or proposed to be acquired, or affected by, construction of Trans Mountain Expansion Project, as deemed necessary by the Board.

If the Board determines a public hearing is required, the Board will permit each person who filed a written statement of opposition that met the requirements of the *National Energy Board Act* (NEB Act) to make representations and may allow any other interested person to make representations before it as the Board deems proper. The Board will take into account all written statements of opposition that have met the requirements of the NEB Act and all representations made at the public hearing in determining the best possible route of the pipeline, and the most appropriate methods and timing of construction for the Trans Mountain Expansion. The Board may impose in any approval, such terms and conditions as it considers proper. Where the Board has held a public hearing in respect of any section or part of the Trans Mountain Expansion Project, and has approved or refused to approve the plan, profile and book of reference respecting that section or part, it will forward a copy of its decision and reasons to the Minister and each person who made representations to the Board at the public hearing.

The Board may fix such amount as it deems reasonable in respect of the actual costs reasonably incurred by any person who makes representations to the Board at such a public hearing, and the amount so fixed will be paid forthwith to the person by Trans Mountain. 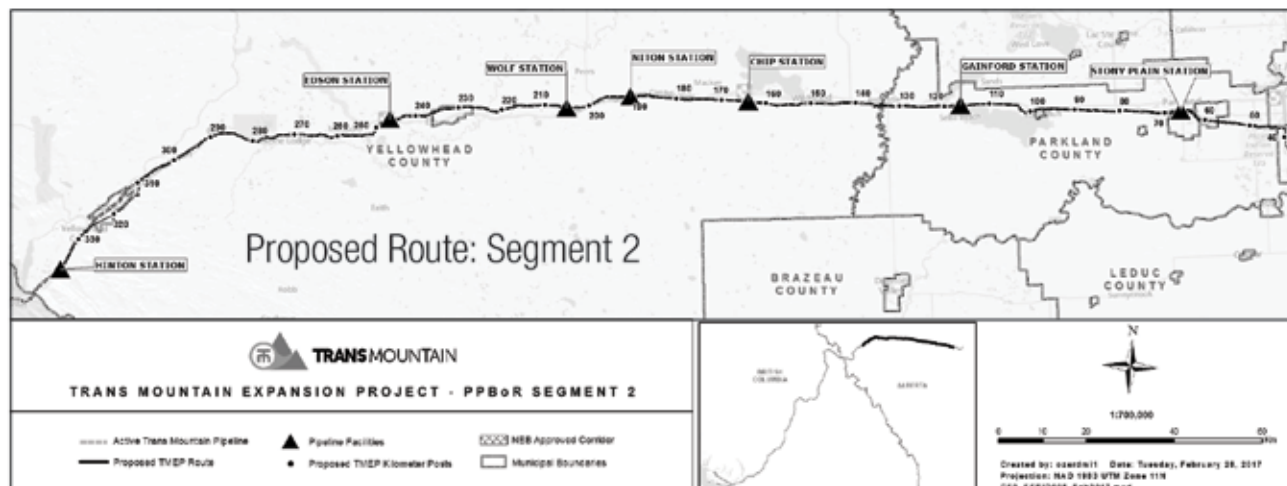

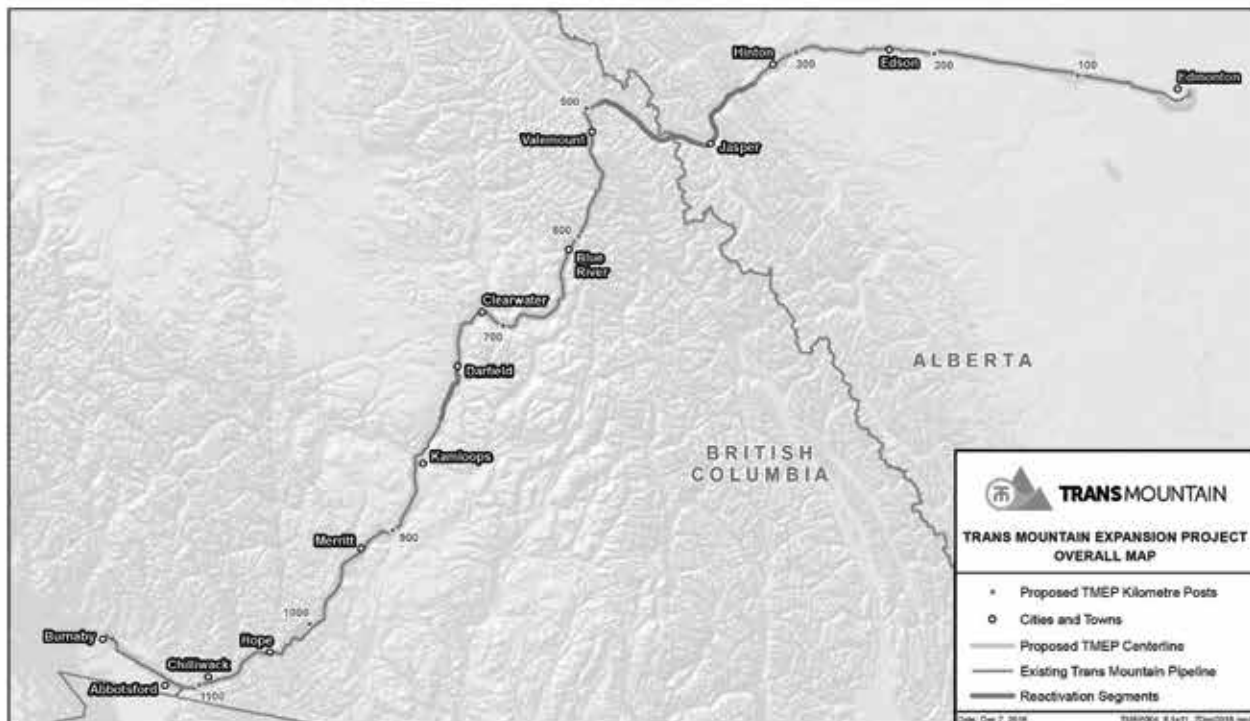

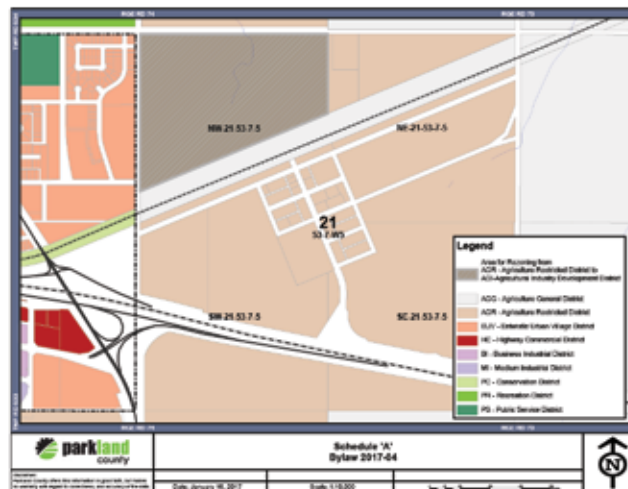
### **Purpose of Proposed Bylaw No. 2017-03: Entwistle Area Structure Plan Amendments**

Amendments to the Entwistle Area Structure Plan Bylaw No. 23-2012 are proposed to introduce more diversity in the types of value added agricultural and agricultural industrial uses to support the Hamlet in the following ways:

- Identifies the need for a range of new value added, agricultural –based industrial and alternative energy-based developments.
- Identifies the CN Railway as an asset and as a catalyst for development.
- Provides accommodation for new agricultural, alternative energy, and agricultural industrial based development in rural and fringe areas.

The proposed redistricting changes the subject parcel located at NW-21-7-5-W5M from AGR-Agriculture Restricted District to AGI-Agricultural Industrial Development District. This will allow for a "General Industrial" land use on the site for the purpose of developing a wood pellet processing facility.

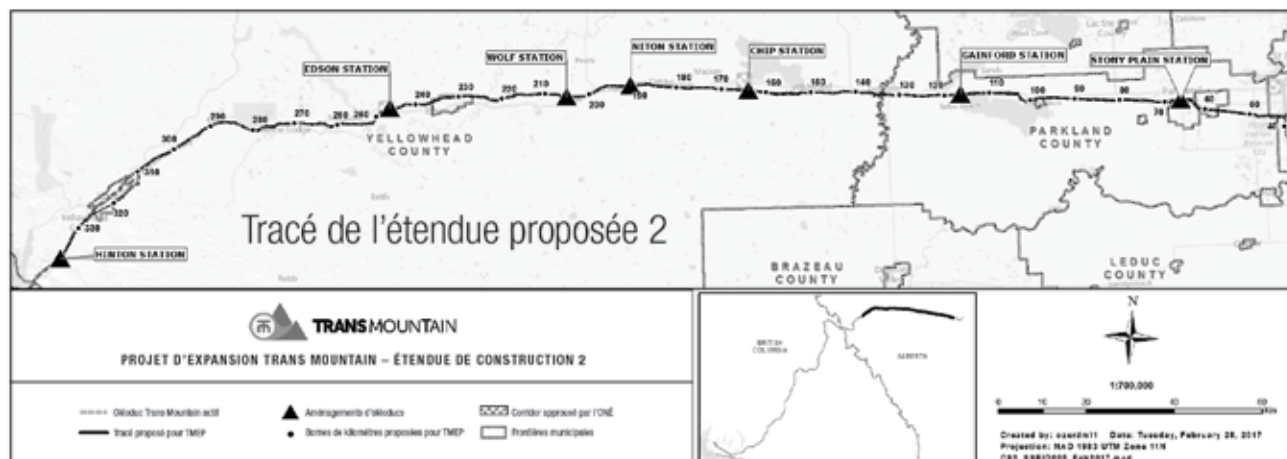

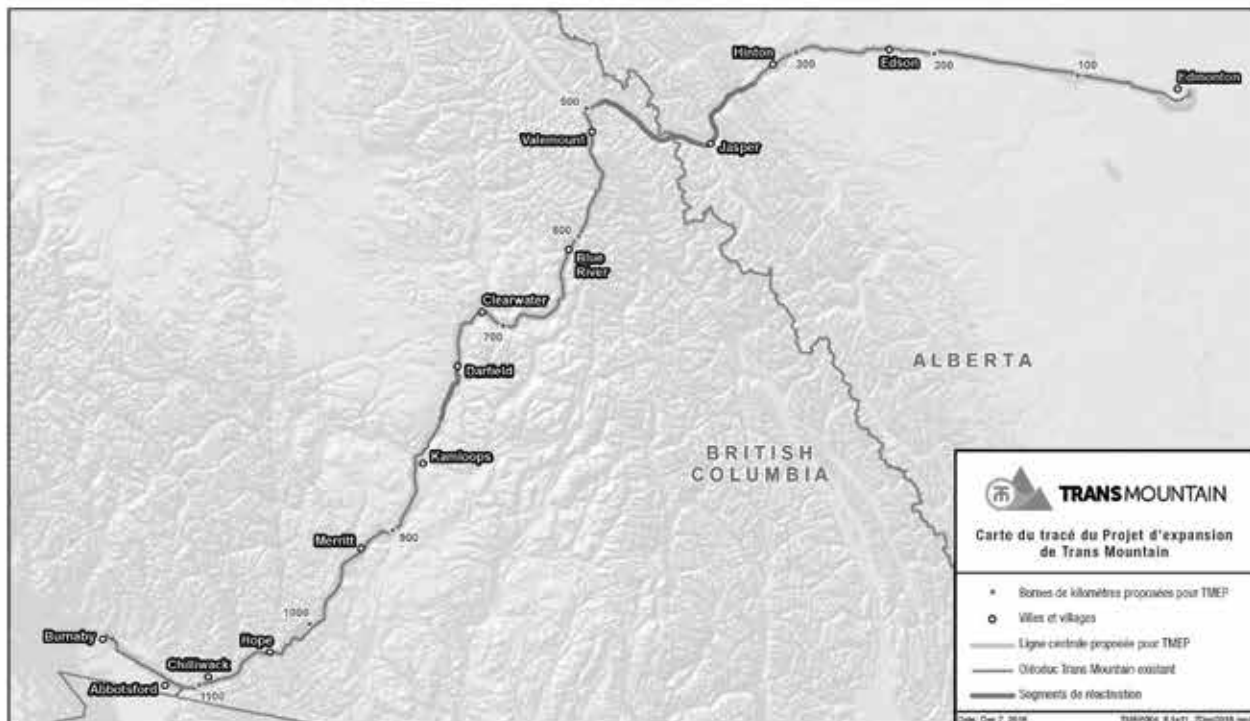

March 1, 2017 Meeting

School Highlights – Lobstick

Staff from Wildwood School joined today's Public Board Meeting to discuss their early literacy practices which are implemented in their Kindergarten and Grade One classes to set the foundation for success in future learning for their students. Students and staff from both schools in Evansburg – Evansview

School and Grand Trunk High School (GTHS) - video-conferenced in during the meeting to also talk about some of their schools' programs. Evansview students from Kindergarten to Grade Six presented to trustees about their school's focus on encouraging a growth vs a fixed mindset when dealing with issues for both students and staff, class student elections and their excitement about a new outdoor garden project. GTHS showcased their Grade Nine/Ten YMCA student exchange program with 16 students currently visiting from Hamilton, Ontario as well as their upcoming 'Taste of GT' event where all the students come together to offer a

variety of food booths for their local community members to enjoy. This year's event will be held at the school on March 23rd.

Learning Updates

The Learning Services team provided an overview on key initiatives being undertaken in their department including:

- Participation in literacy and numeracy workshops offered to GYPSD school staff
- Resources and support provided to new teachers
- Technology updates including replacement of all school firewalls by June of 2017 and G Suite pilot project update at Harry Collinge High School

in Hinton

• A report noting the inclusive education initiatives and supports implemented this school year including the proposal to hire an additional speech-language pathologist and occupational therapist for the division.

Other News in Brief

• The division is pleased to forward their nomination for this year's Edwin Parr Award for recognition of outstanding achievements of first year teachers in the province which is sponsored by the Alberta School Boards' Association. This year's nominee for GYPSD is Spencer Hayes from Niton Central School.

• Trustees went over a proposed cost recovery plan for the division's upcoming transportation budget for the next five years. Information in the proposed plan included options for decreasing expenditures as well as increasing transportation revenues. Some of them being considered include increasing fees for ineligible students, route consolidation, re-allocating department vehicle expenses and reviewing necessary capital purchases. A reduction of transportation staff was also proposed as an option in the proposed debt recovery plan but was not recommended by administration for consideration at this time.

• A letter from Alberta Education in response to the division's current 3 Year Education Plan and Annual Educations Results Report was given to trustees which recognized the work being done in the division in the areas of inclusive education and for first Nations, Métis and Inuit students.

Capital Projects Update

Facility Services provided their regular updates to the Board on two current capital projects in the Division: the modernization project for Grande Cache Community High School (GCCHS) and the new replacement school in Edson, Mary Bergeron Elementary.

GCCHS: The cement slab in the gathering area has been poured and trustees were impressed with the stained concrete floor design for the entry. The painting in the gym is almost completed with the hardwood flooring scheduled for installation in the first part of March. The office millwork is being installed and should be completed by the middle of February. The new mechanical system will be operational before the end of the month.

Edson: The gym masonry walls have been completed and the trusses installed. Construction of the music room and mechanical room walls has started and is scheduled to be completed at the end of February.

### Other News in Brief

- Trustees approved Eight Budgeting Principles for the upcoming 2017-18 year which defines the parameters for them to assign resources of the Division in meeting their identified priorities in a transparent and consistent manner:

- Plan and Budget
- Timelines and Blocks
- Stakeholders
- Funding Allocation
- Budget Philosophy
- Balanced Budget
- Reserves
- Resource Utilization

- For the current school year, GYPSD transports more than 2,700 students over 32,000 kilometers and operates 56 school bus routes. As part of the provincial funding application for transportation, the division is required to complete information on various statistics including those students requiring additional supports and types of passengers transported. The Board received a detailed report provided by Gail Prokopchuk, Director of Transportation Services, for their information.

- In order to provide meaningful, supportive and inclusive learning environments for students, GYPSD encourages all stakeholders to participate in various surveys. 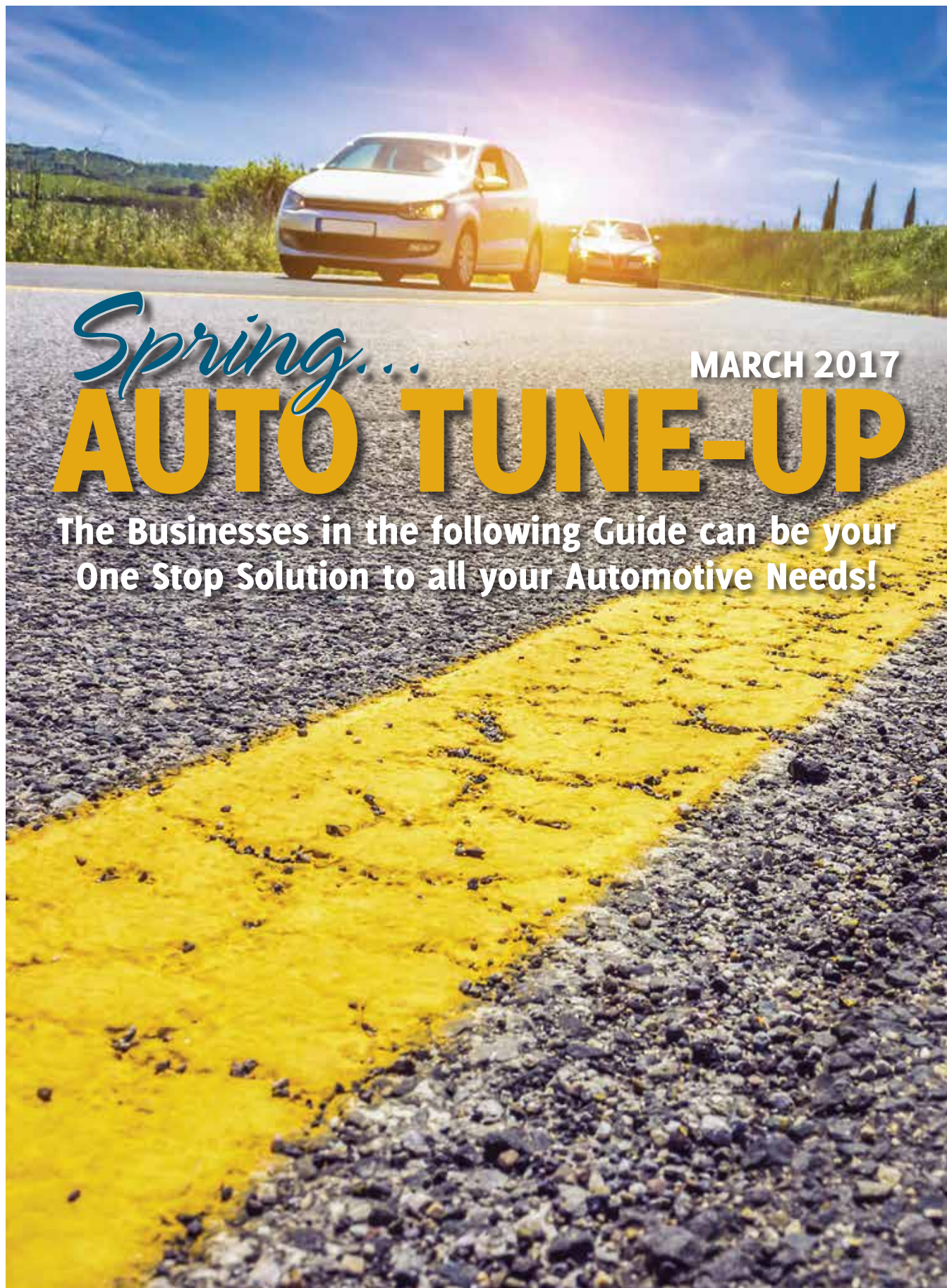

## WHAT TO DO AFTER BEING INVOLVED IN A CAR ACCIDENT

Car accidents happen every day, and rare is the experienced driver who has not been involved in at least one accident during his or her time behind the wheel. Drivers or passengers who have been involved in previous accidents may react calmly when involved in another accident, but the experience of being in a car accident can be shocking to those people who have never before been involved in a car crash.

According to the World Health Organization, there were 1.25 million road traffic deaths across the globe in 2013. But not every traffic accident involves a fatality, and many are minor incidents in which all involved parties walk away unharmed. Unfortunately, all traffic accidents, however minor they may be, have financial ramifications, and it's in drivers' and

passengers' best interest to familiarize themselves with the right way to respond to traffic accidents should they find themselves in a crash.

- **Dial emergency services.** After pulling over and out of traffic, drivers and passengers involved in traffic accidents should dial 9-1-1 emergency services. If drivers are incapable of pulling onto the shoulder or out of the way of oncoming traffic, immediately put on the vehicle's hazard lights and dial 9-1-1. Enlisting the help of emergency services like 9-1-1, even when no one appears to be injured and no vehicles seem to be damaged, is necessary because the presence of a neutral third party like a police officer or emergency medical technician can be helpful should the accident ultimately lead to legal action.

- **Exchange insurance information.**

After each driver has pulled over and is out of harm's way, attempt to exchange insurance information. If you lost your insurance card or can't find it in your vehicle, don't panic. Simply use your mobile phone to call your insurance company and get your policy number. Police may let you off the hook if you can provide proof of insurance, even if you don't have any such proof in your vehicle. If the other driver appears irate and/or confrontational, wait until the police arrive to exchange insurance information and do your best to avoid this person.

- **Obtain a police report.** Police reports are vital, even when accidents are minor. Insurance companies may not pay damages if no police report has been filed and the involved parties have differing accounts of the ac-

cident. And drivers' premiums may increase if they are involved in an accident in which no one is deemed at-fault. Always protect yourself after a traffic accident by calling the police and obtaining their official report of the incident. Also, ask the responding officer if you are required by law to report the accident to the local motor vehicle agency. Some areas require this, while others do not.

- **Take photos.** If you have a smartphone or camera on hand, take as many photos of the accident as you can without risking your safety. Time-stamped photos may help you should a lawsuit or other legal action be taken in the future.

Car accidents can be scary, and knowing how to respond to accidents can help drivers and passengers make the best of unfortunate situations.

## PREVENT BUGS, SAP AND OTHER SUBSTANCES FROM RUINING A VEHICLE

Keeping vehicles looking pristine requires care and diligent cleaning. So many day-to-day activities and environmental materials have the potential to damage the finish on cars and trucks. While winter weather and chemicals used to keep roadways passable are often blamed for affecting the appearance of cars and trucks, winter is not the only time of year when substances can cause damage to vehicles. Spring and summer are prime seasons for sap, birds and insects. These times of year tend to see an uptick in road work as well, and such projects can contribute to damage caused by loose asphalt, gravel and tar. Addressing problems resulting from tree sap, insect and bird droppings and tar may not be something to look forward

to, but it is necessary to keep cars looking pristine.

### Tree sap

According to Cars.com, an automotive information resource and vehicle sales website, although tree sap won't cause immediate damage to vehicle paint, it should not be ignored. Over time, sap can become more difficult to remove, etch through the clear coat on the vehicle and cause discoloration. When the temperature is hot, damage from sap can accelerate.

On windows and windshields, drivers may be able to gently remove dried sap with a razor blade. However, use cleaning products on more delicate paint. Automotive stores sell specialty sap and tar cleaners. Otherwise, you can try rubbing alcohol. It may take a few

attempts to remove sap entirely.

### Insects and bird droppings

Splattered bugs and avian surprises dropped from above can be a messy, unsightly nuisance. Their acidic composition also may cause them to damage paint over time. Bugs and droppings can be sticky, so you will need to work with something that will remove the splatter without removing the paint in the process. A product like WD-40 may help. This oily product is normally used on rust and hinges. When applied with a cloth and allowed to penetrate the stain, it can loosen difficult-to-remove sticky substances. Always test any product you use in an inconspicuous spot first to make sure it doesn't damage or discolor your the paint.

Insects or droppings that are


fresh may come off relatively easily with a good washing or hosing off of the car. Retailers also sell specialty insect sponges to remove bugs and other debris.

### Tar

Soap and water will do little to remove tar and other petroleum-based products from vehicles. Commercial tar removal products use a strong solvent or detergent to loosen the tar. This may include kerosene, mineral spirits or another item mixed with lubricants. Go slowly and use caution so that you remove the tar and not the paint.

Drivers who are hesitant to clean their vehicles of common residue can have their cars or trucks professionally detailed, leaving the work in the hands of experts.

## TIRE MAINTENANCE A KEY COMPONENT OF SPRING CHECK-UP

When warm weather arrives, many people enjoy a collective sigh of relief. Just as people welcome the end of the cold, snow and ice, cars and trucks also can benefit from more moderate temperatures.

Salt, grime and pot holes can take a toll on tires over the course of a typical winter. Drivers will not get far this spring and summer without tires in good repair, which is why tire maintenance should be part of any seasonal repair checklist.

### Inflation levels

Now is the time to use a tire pressure gauge to see if tires are at the ideal inflation levels. Many tires indicate the recommended PSI (pounds per square inch) on their sidewalls. Cold temperatures may cause tires to deflate a little. Esurance states that winter weather can cause tire pressure reduction at about one PSI for every 10 degrees the temperature drops. Driving on improperly inflated tires can be dangerous, potentially affecting handling and braking distances.

Check tires when they are cold for the most accurate reading. Properly inflated tires also will improve fuel economy, so drivers may even save a little money by inflating their tires.

### Tire rotation/realignment

Examine the tires for tread wear. Any uneven or abnormal tread wear could indicate that the tires need to be rotated and the wheels realigned at the very least. Take the vehicle to a qualified mechanic to get their opinion on how to remedy the situation. Mechanics may recommend rotating tires every 6,000 to 8,000 miles, or about every six months for the average driver.

Wheel realignment may be necessary after a season of driv-

ing over potholes and other irregularities in the road. Misaligned wheels can cause handling problems, like the car 'pulling' to one side.

### Tire replacement

Drivers may discover extreme

tread wear, bulges or even cracks in the sidewall during a tire inspection. These signs indicate that it's time to replace the tires. Failing to replace old, worn down tires can increase the risk of automobile accidents.

### Thorough cleaning

Once tires are inspected and possibly serviced or replaced, treat the car or truck to a washing and thorough detailing. This will help tires shine and get the vehicle road-ready for spring trips.

February 28, 2017

Regional Waste Management Budget – Council formally adopted the West Yellowhead Regional Waste Management Authority's 2017 Capital & Operating budgets. Yellowhead County, the Town of Edson, the

Town of Hinton, and the Town of Jasper make up the regional authority.

Road Priority Map & 5 Year Road Reconstruction Plan – Council formally adopted the County's Connectivity/Collector Road Priority Map and the Five-Year Road Reconstruction Plan. This will allow Yellowhead County to move ahead with the planning of these road projects. These construction projects have

been identified as the top priorities for County roads.

Property Assessment Exemption Status – Eleven non-profit organizations received property assessment exemptions until 2019. These eleven organizations have met the Municipal Government Act requirements that allows their assessment to be exempt from taxation in Yellowhead County.

Tervita Landfill Expansion –

Council defeated Bylaw 18.16 following Tervita Corporation's application for the rezoning required for their proposed industrial landfill expansion near Carrot Creek Tower Road. A Public Hearing was held on February 14, 2017 and gave Council the opportunity to hear from both sides of the proposed landfill expansion prior to making a decision whether or not to change the zoning of the property from Rural District to Rural Industrial District.

The next Council Meetings are March 14 & 28, 2017. The next Committee of the Whole Council Meeting is April 18, 2017. All meetings start at 9:30 a.m. in the Council Chambers.

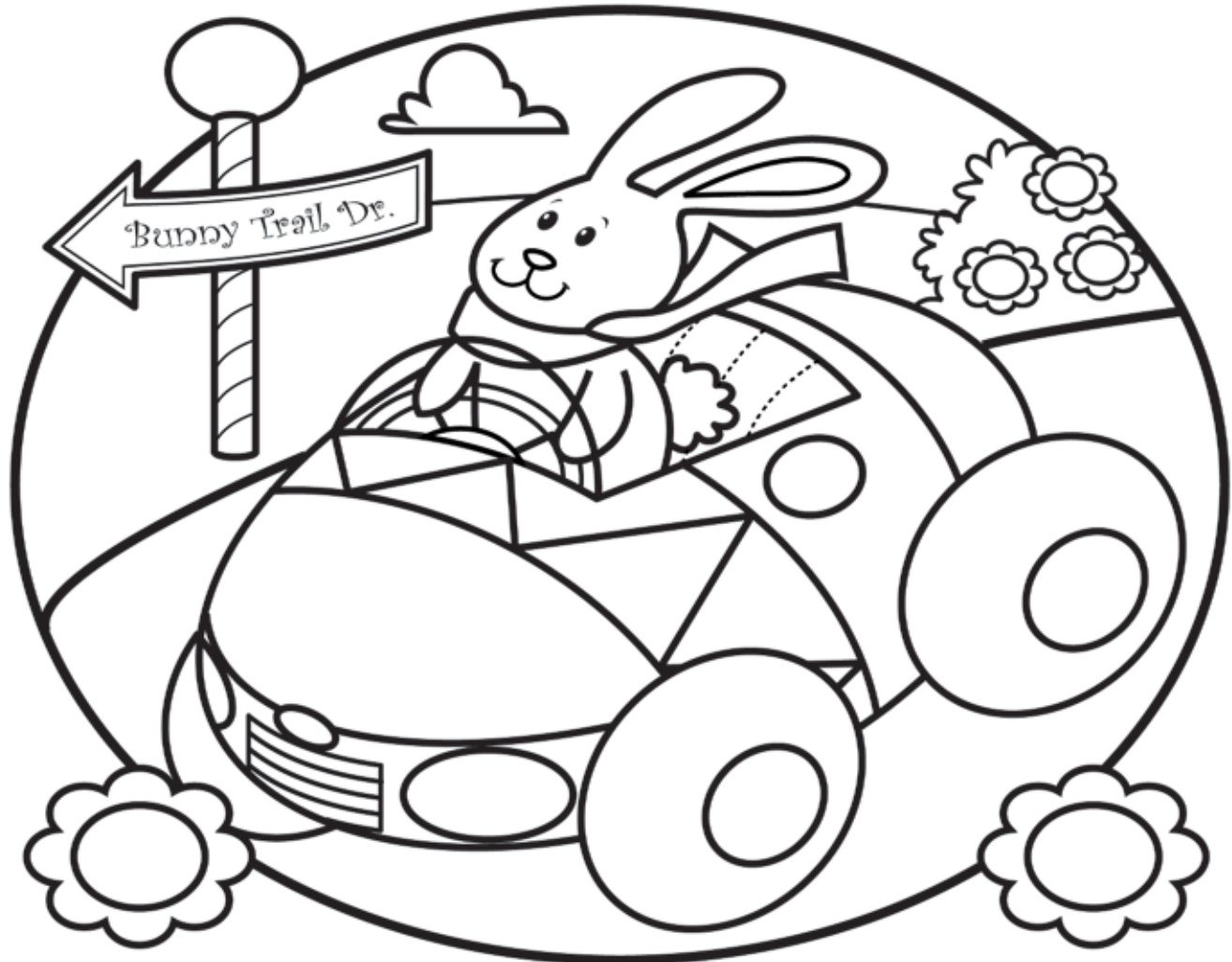

# SHENANIGANS IN FINANCE COMMITTEE

On March 7th, in Ottawa at the House of Commons Standing Committee on Finance Conservative MP Ron Liepert, asked to undertake a study into Alberta's economy and current unemployment levels.

The committee has no agenda scheduled for any meetings in

March as the Government has not presented any agenda items to study. This was a great opportunity for Albertans to have their voices heard by Government. However, despite more than an hour of presentations by Conservative members of the committee as to the merits of such a study, the Liberals used their majority to defeat the motion.

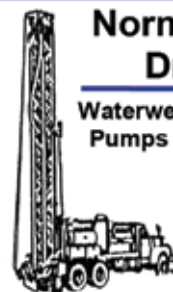
