RCMP REQUEST PUBLIC'S ASSISTANCE IN IDENTIFYING A PERSON OF INTEREST

On December 31, 2017 at approximately 7:00 pm, Drayton Valley RCMP were called to an incident where a person had been shot at from a vehicle by an unknown male on Highway 624. The victim was not seriously injured in the incident. The suspect vehicle, a white 2010 or newer Ford F150, 4 door truck with possible BC plates, left in an easterly direction on Highway 624. There were 4 occupants in the vehicle, 2 males in the front and 2 females in

the back.

The one male suspect was described as follows:

- · Caucasian male, approximately 45 years old
- · rough complexion, brown eyes, dirty blond/light brown hair
- · Hair was longer, stuck out the
- sides of the hat
- round glasses
- green hat with yellow mesh on the back
- stubble on face
- scar on lower right chin
- 5'9" 6' tall, slender build

was developed from the description provided by the victim.

LEDUC DRUG UNIT MAKES THIRD SIGNIFICANT DRUG BUST OF 2018

On Wednesday January 17, 2018 Leduc RCMP's Drug Unit laid several Criminal Code and Controlled Drugs & Substances Act charges as a result of search warrant. This is the third major drug bust by the Drug Unit in Leduc this year. Police executed a search warrant at a local residence seizing large amounts of methamphetamine and hashish. Police also found weapons, cash and other items related to the drug trade.

During the takedown 11 people were taken into custody. Six were released without charge and five are facing charges.

22 year old Allyssa BOULIANNE and 23 year old Steven BABYCH are jointly charged with possession of methamphetamine and hashish for the purpose of trafficking, possession of property obtained by crime, and weapon offences.

18 year old Brandon MCGRE-GOR is facing 2 counts of trafficking methamphetamine.

28 year old John HEITZMAN has been charged with possession of methamphetamine.

28 year old Travis CARR, who was also wanted on a warrant for being unlawfully at large, faces a charge of possession of methamphetamine.

All five individuals will be appearing on various dates in Leduc Court. BABYCH, BOULIANNE and CARR remain in custody, HEITZ- MAN and MCGREGOR have been released on conditions.

Leduc RCMP Operations NCO Staff Sergeant Chad ORR commented on the bust: "We have organized a unit of highly trained, and highly skilled drug investigators with a mandate to disrupt drug trafficking operations that attempt to set up shop in our community. The Drug Unit's overwhelming success not only keeps these dangerous substances out of the hands of the public but also makes a huge impact on other crimes. The drug subculture contributes to all crimes ranging from violent assaults to routine property crime and by removing major players involved in drug trafficking we can help prevent future crime across the board."



PARLIAMENT UPDATE – WEEK OF JANUARY 29, 2018

This week Parliament reconvened for the spring session.

The following was debated in the House:

• Bill C-50 – An Act to amend the Canada Elections Act (political financing) (Report Stage)Bill C-62 – An act to amend the Federal Public Sector Labour Relations Act and other acts (Second Reading)

• Bill C-65 – An Act to amend the Canada Labour Code (harassment and violence), the Parliamentary Employment and Staff Relations Act and the Budget Implementation Act, 2017, No. 1 (Second Reading)

• Bill C-348 – An Act to amend the Department of Employment and Social Development Act (persons with disabilities) (Second Reading)

• Bill C-365 – An Act to amend the Criminal Code (firefighting equipment) (Second Reading)

• Bill S-2 – Strengthening Motor Vehicle Safety for Canadians Act (Third Reading)

• Bill S-5 – An Act to amend the Tobacco Act and the Non-smokers' Health Act and to make consequential amendments to other Acts (Second Reading)

• M-124 - Automated external defibrillators (Agreed to)

• M-133 – British Home Child Day

• M-148 – National Impaired Driving Prevention Week

On Monday, I participated in debate by asking questions on Bill C-65, which strengthens the existing framework for the prevention of harassment and violence, including sexual harassment and sexual violence, in the work place.

On Tuesday, I gave a statement in the House, congratulating Grande Cache on the sale of their steelmaking coal mine. The new owners plan to restart operations after the purchase closes later this spring.

On Thursday, I participated in debate by asking a question on Bill C-62, which deals with the collective bargaining process for civil servants.

On Friday, I participated in debate by speaking on M-148, which is a motion to establish National Impaired Driving Prevention Week in the third week of March each year; I asked a question on Bill C-50, which changes the rules around cash-foraccess political fundraisers; and, I gave a statement in the House on the Prime Minister's refusal to provide funding for injured veterans.

FUNDING AVAILABLE FOR ENERGY EFFICIENCY RESEARCH

OTTAWA: Jim Eglinski, Member of Parliament for Yellowhead, is pleased to inform residents of a call for Expression of Interest (EOI) under the Energy-Efficient Buildings RD&D Program.

The \$48.4 million program is provided through Natural Re-

sources Canada and will support the development and implementation of building codes for existing buildings and new net-zero energy-ready buildings through RD&D initiatives that:

• Accelerate development and adoption of technologies, design and construction

Provide more cost-effective solutions

• Validate locally with real-world demonstrations

• Build confidence for adoption of updated codes

Only Canadian organizations are eligible and the repayable contribution is expected to range from \$250,000 to \$5 million per project.

The deadline is February 21, 2018.

"Energy conservation is very im-

portant. When we conserve energy, it costs less to heat and light our homes. I encourage any local, eligible organizations to consider applying for this funding," concluded MP Eglinski.

FUNDING OPPORTUNITY FOR FARMS HIRING YOUTH

OTTAWA: Jim Eglinski, Member of Parliament for Yellowhead, is pleased to inform local farm operators and employers in the agricultural sector that the Agricultural Youth Green Jobs Initiative application period is now open.

Projects can start on April 1, 2018 with the possibility of starting earlier based on available funding. Projects must also be completed by March 31, 2019. The Agricultural Youth Green Jobs Initiative helps fund internships for post-secondary graduates and high school students working in the agriculture industry. These internships include activities or projects that benefit the environment.

Funding is available through the following two streams:

1. Green Farms Stream: Farm operators could receive up to a maximum of \$10,000 per youth intern, 30 years old or younger, including high school students to implement projects that are environmentally 2. Green Internships Stream: Employers in the agricultural sector but not directly on a farm could receive

not directly on a farm could receive up to a maximum of \$16,000 per post-secondary graduate intern to undertake environmental activities, services or research that will benefit the agriculture sector.





OTTAWA: Jim Eglinski, Member of Parliament for Yellowhead, is pleased to inform local residents of funding opportunities available through a "call for concepts" for projects that support survivors of gender-based violence (GBV) and their families.

Some populations living in Canada experience dispropor-

tionate levels of violence and face challenges to accessing services. These populations include children and youth, Indigenous women, non-status/refugee/immigrant women, seniors, and women living in northern/rural communities.

"Gender-based violence continues to have devastating impacts on Canadian individuals, families and communities. The effects of such violence can be long-lasting and profoundly affect many aspects of a person's life," stated MP Eglinski.

Through this call for concepts, targeted funding opportunities will be provided to organizations working in the GBV sector to support population-specific survivors and their families.

The deadline to submit a concept is 12:00 p.m. (PT), on March 1, 2018. Projects can be funded for a period of up to five years, and the maximum funding amount has been increased to \$1 million per project.

There are two separate calls for


proposals:

becoming a conservation concern, by engaging Canadians in conservation. The optional Expressions of Interest are due February 23, and the deadline to apply for funding is March 19, 2018.

The Aboriginal Fund for Species at Risk supports the development of Indigenous capacity to participate actively in the implementation of the Species at Risk Act (SARA). The deadlines are the same as the HSP for Species at Risk, above.

The EcoAction Community Funding Program is available for new projects that engage Canadians and clearly demonstrate measurable, positive environmental results related to clean water or climate change. The deadline to apply is March 21, 2018.

The Environmental Damages Fund has two streams in Alberta. The first has \$170,000 available for the conservation and protection of fish and fish habitat. The second has \$200,000 available for projects that protect, conserve, or restore the environment. Preference for both streams will be given to projects in our North Saskatchewan River watershed. The deadline is February 23, 2018.

"I encourage all those interested in these programs, especially those along the North Saskatchewan River, to apply. Let's ensure that our riding of Yellowhead continues to represent the best of Alberta's beauty," concluded MP Eglinski.
