STOLEN VEHICLES RECOVERED

Carvel, Alberta- On September 17 at approximately 12:50 am RCMP were contacted by Onstar to report that they had located a Chevrolet Silverado that had been stolen on September 16, 2018. Onstar advised that they had performed an ignition block and the vehicle was no longer driveable. RCMP attended and located the vehicle parked on the side of Highway 770 near Highway 16. While on scene,

members located a Ford F150 with a boat trailer and a Ford Escape with a stolen licence plate that had also been stolen earlier in the day.

RCMP utilized the Police Dog Service (PDS) and a track was picked up from one of vehicles, a male was located a short distance away laying in the bush.

Blaine ELESKO, a 47-year-old male from Yellowhead County was charged with:

- Sec. 335(b) Criminal Code- Possession of Property Under \$5000

- Sec. 733.1 Criminal Code- Fail to Comply with Probation Order

ELEKSO was released from custody with conditions and will appear in Stony Plain Provincial Court on September 26, 2018.

Both the Silverado and the F150 had been left with the keys in the vehicle. "We want to encourage people to take precautions and lock their vehicles," says Constable Megan Purton from Stony Plain detachment. "A lot of these are crimes of opportunity and are preventable."

MP JIM EGLINSKI NAMED TO NEW COMMITTEES

OTTAWA: MP Jim Eglinski, Member of Parliament for Yellowhead, has officially been named to two new committees: the Standing Committee on Public Safety and National Security (SECU) and the Standing Joint Committee on the Library of Parliament (BILI).

SECU reviews the policies, programs and expenditure plans of government departments and agencies responsible for public safety and national security, policing and law enforcement, corrections and conditional release

of federal offenders, emergency management, crime prevention and the protection of Canada's borders.

BILI consists of Members from both the House of Commons and Senate, and it assists the Speakers of both Chambers in reviewing the effectiveness, management, and operation of the Library. The Speakers of both chambers, assisted by the Joint Committee, direct the day-to-day functioning of the Library, and, with the approval of both Houses, may make orders and regulations to govern how the Library is managed and how moneys are expended. The Joint

Committee, under this arrangement, plays a role in the direction of the Library of Parliament by supporting the Speakers as they provide direction to the Library.

"Given my 35 years of experience as an RCMP member, I am excited to bring my practical knowledge to the table. The Liberals have been failing Canada on matters of national security, including border security and increased crime and gang activity. I look forward to playing an active role in keeping this Liberal Government to account for their failures," concluded MP Eglinski.

Parkland County, Alberta- On September 7, 2018 at approximately 10:20 p.m. police responded to a complaint of a

CONSULTATION – POLITICAL ACTIVITIES OF CHARITIES

OTTAWA: Jim Eglinski, Member of Parliament for Yellowhead, would like to inform residents that the Department of Finance has launched a 30-day public consultation period on draft legislative proposals to remove the quantitative limits on political activities from the Income Tax Act.

Under these draft legislative proposals, charities would still be required to be constituted and operated for exclusively charitable purposes, meaning they cannot have a political purpose, and restrictions against partisan political activities would remain.

The draft legislative proposals would apply retroactively to related audits and objections that are currently suspended. As announced on August 15, 2018, the Canada Revenue Agency will soon issue supporting administrative guidance for consultation with the charitable sector on how it would implement the legislative proposals released today.

REGARDING WILDWOOD SCHOOL, EVANSVIEW AND GRAND TRUNK FACILITY REVIEW

It's great to see a community like Wildwood pull together when there is a pending possibility of it being pulled apart. I was glad to see our Yellowhead County Mayor, Gerald Soroka, and Councilor Anthony Geizen attend the Grande Yellowhead Public School Division workshop on Thursday, September 13, 2018 at the Wildwood Community Hall; although the decisions for GYPSD 3 year Capital Plan are not governed by Yellowhead County and rely solely on the GYPSD Board of Trustees to make the best decision for the stakeholders who are directly impacted; the County's support and efforts are greatly appreciated.

Yellowhead County recently approved a manufacturing plant to build within the hamlet of Wildwood, which would employ a minimum of thirty employees and potentially attract new residents and families into the area. Alongside the new manufacturing company, Yellowhead County has added new amenities such as the kids pump track in Gunner Park; a new beautiful Fire hall, County supported Public Library. A community-based school is imperative to retain.

Of the four Capital Plan options brought forward by GYPSD Board of Trustees, only one offered an alternate to closing the Wildwood School, and that was to keep all three of the

schools open. The meeting attendees were broken down into smaller groups of 6-8 individuals at a table with all of our questions, concerns, comments, and ideas funneled through a facilitator at each table and presented to the Board. While there were a lot of great ideas and questions brought forward by each table, some felt that there was a lack of interaction among the Board Members and the attending community members as everything was communicated through a facilitator and moderator.

Many of the options brought to GYPSD Board Trustees by the community included a new K-12 school in equal distance between both Evansburg and

The most repeated and popular idea, I feel, was keeping Wildwood School K-6 and modernizing Grand Trunk and consolidating Evansview the Evansburg schools into one K-12 school. These were only a few of the several options presented by the Community to the Board of Trustees via our facilitators.

So, do I feel this was a great workshop? Well, I do feel the company that was hired by GYPSD to mediate this workshop did a great job of conveying our concerns and ideas. Now I look forward to attending

the drop in sessions on September 19 (In Grand Trunk High School, Evansburg) and September 20 (in Wildwood School, Wildwood) and have already begun to register and reserve a spot for the Special Meeting on September 27, 2018 in EDSON at the Edson Legion. You must call to reserve your spot in order to attend. The information to reserve your spot was not included at the meeting but you may do so with GYPSD administrative assistant Brenda Froese (780-723-4471). We have been told that that the meeting is being held in Edson because legislation dictates it be held where the Board holds its office although, an exception is being made to move to the Legion. There will be no

exception to hold this meeting in either of the two communities that are directly impacted by the decision outcome.

This meeting will be their final decision and I am interested to see if the Board adopts one of the new options brought forward by stakeholders or it continues with one of theirs. In either case, the GYPSD Board of Trustees needs to take the appropriate amount of time to make the right decision for the stakeholders and not rush the process.

Sometimes when you are in a position of power such as a Board, you need to hear some negatives to make you feel grounded and realize that the communities are why you are in the position you are in. A Board

should exist to serve the stakeholders to the best of their ability

I am a former graduate of GYPSD, and now a parent of two children enrolled in the same. I can understand the need and benefits of a community based school and hope that our respected Board of Trustees now understands what that means as well. Wildwood needs a school to be a community. A Community that will thrive through difficult times for years to come. A college of mine at work recently said to me, "they'll just do what they want, it doesn't matter what you do." I say that everything you do matters.

Proposed Bylaw 2018-18 Parkland County and Yellowhead County Intermunicipal Development Plan

An Intermunicipal Development Plan (IDP) is a statutory document prepared with two (or more) municipalities that share a common border, and where at least one member is not a part of a growth management region. An IDP ensures future development and land use policy are coordinated between municipalities. Parkland County and Yellowhead County, under the direction of Section 631 of the Modernized Municipal Government Act, have agreed to jointly engage in an IDP. This plan has been developed to reduce the possibility of any potential conflicts between Counties and to ensure the relationship remains strong, transparent and collaborative in the future.

Hearing Procedure

This is a formal Public Hearing and Council is prepared to hear and receive formal submissions and presentations (verbal or written) from those who wish to speak to the proposed Bylaw. Written submissions or presentations may either be submitted to Planning & Development by 4:00 P.M. on October 2, 2018, or submitted at the commencement of the Public Hearing.

Anyone wishing to make a verbal presentation to Council must notify Planning & Development Services by 4:00 P.M., on October 2, 2018. Verbal presentations at the Public Hearing will be limited to a maximum of 10 minutes. Anyone wishing to make a verbal presentation who has not made prior arrangements may be allocated a time at the commencement of the Public Hearing. Council advises that this is your last opportunity to comment on the proposed Bylaw as Council is unable to receive further submissions after the Public Hearing is closed.

GOVERNMENT OF CANADA REACHES SETTLEMENT IN COURT CASE WITH PARENTS WHO WERE DENIED EMPLOYMENT INSURANCE SICKNESS BENEFITS WHILE ON PARENTAL LEAVE

The Honourable Jean Yves Duclos, Minister of Families, Children and Social Development, together with Ms. Jennifer McCrea, announced that a settlement agreement has been reached to resolve a class action between the federal government and parents who, between 2002 and 2013, applied for Employment Insurance (EI) sickness benefits while in receipt of EI parental benefits and were denied.

The Government of Canada recognizes the challenges faced by Canadians who cannot work because of illness, injury and other family challenges and has reached a settlement agreement with the McCrea class to bring closure to these legal proceedings. If the settlement is approved by the Federal Court, class members will receive an amount equal to the EI sickness benefits they would have received at the time had their claims been approved. The total settlement amount is estimated at between \$8.5–\$11 million.

Improving the EI program is a priority for the Government of Canada. Several measures have recently been implemented to ensure that the program is better aligned with the realities of today's labour market and that Canadians have access to benefits when they need them most.

In Budget 2017, the Government of Canada announced increased support to parents and family caregivers by providing them with benefits that are more flexible, inclusive and easier to access in order to better meet their unique family and work circumstances. These changes to maternity, parental and caregiving benefits came into effect on December 3, 2017.

In Budget 2018, the Government of Canada announced that the Working While on Claim pilot provisions will be extended to EI maternity and sickness bene-

fits so that Canadians who wish to gradually return to work after an illness or the birth of a child have flexibility to do so without jeopardizing their EI benefits. These changes came into effect on August 12, 2018.

Quick Facts

- The McCrea class, which was certified by the Federal Court on May 7, 2015, is comprised of parents who, between 2002 and

2013, applied for sickness benefits while in receipt of parental benefits and were denied.

- Prior to 2013, claimants could not switch from parental benefits to sickness benefits unless they could show that they were otherwise available for work.

- In 2013, access to sickness benefits was expanded on a go forward basis to allow claimants who became sick while in receipt

of parental benefits to claim sickness benefits and subsequently revert to parental benefits.





Home improvement projects provide homeowners with a chance to put their own stamp on their homes. In addition, many such projects make homes safer and, in some instances, more eco-friendly.

The opportunity to make a home more comfortable, safer and/or more eco-friendly entices many homeowners to open their wallets. In fact, the Home Improvement Research Institute estimates that the home improvement products market will grow by more than 5 percent in 2018.

Homeowners might experience some sticker shock when researching home improvement projects or receiving estimates from contractors. But there are ways for budget-conscious

homeowners to transform their homes and still make the most of their home improvement dollars.

- Do your homework. Each year, Remodeling magazine publishes its "Cost vs. Value Report," a comprehensive study of 21 popular remodeling projects in 149 United States markets. The report notes the value each project retains at resale in 100 markets across the country. Homeowners who want to get the strongest return on investment can access the "Cost vs. Value Report" (www.remodeling.how.net) to see which home improvement projects are best suited for them.

- Do some of the labor yourself. Homeowners willing to swing a hammer also can stretch their

home improvement dollars. For example, the home improvement resource This Old House® notes that homeowners willing to do their own demolition before the contractors arrive can save substantial amounts of money. A professional contractor may charge \$1,000 to demo a 200-square-foot deck, but This Old House estimates that homeowners who demo their own decks may spend only \$450 (for the dumpster rental and parking permit).

- Hire a consultant. The DIY movement is incredibly popular, no doubt thanks to television channels such as HGTV and the DIY Network. Homeowners with DIY experience may be able to complete projects on their own with little consultation from pro-

fessional contractors. Some contractors may not offer consulting services, however. The consultation route, which typically requires paying licensed contractors hourly fees to offer guidance, should only be considered by homeowners with legitimate DIY skills, for whom this option can be a great way to save money.

- Schedule renovations during homeowner-friendly times of year. Summer and fall tend to be contractors' busy seasons, and homeowners will likely pay more for projects during this time of year. If possible, delay starting projects until right after the new year, when contractors aren't so busy and might be more flexible with pricing.

WHAT TO DO WHEN A PROJECT STALLS

Upon embarking on a home improvement project, homeowners who have never before lived through such undertakings are often told to expect their projects to take more time than initial estimates suggested. Unforeseen complications can compromise project timelines, and some homeowners may find their projects stuck in neutral.

Stalled projects can make life at home difficult, and homeowners may feel helpless with regard to getting a project back on course. But there are ways for homeowners to get stalled projects back on course.

- Start off on solid financial footing. It's important that homeowners who want to upgrade their homes enter the home improvement process with a realistic grasp of their finances. Many home improvement

projects stall when homeowners run out of money. Homeowners can avoid such unfortunate situations by only beginning a project they know they can afford. Certain home improvement projects may not require advanced skills, and even friends or family with little or no home improvement experience can pitch in to complete such projects. When more advanced

projects stall, homeowners may want to hire contractors to complete the work. If budgets have not left much room for hiring a contractor, homeowners can perform some of the labor on their own.

- Be mindful of permits. Some home improvement projects require permits, and these permits often have expiration dates. Homeowners must keep permits in mind when projects start to stall, recognizing that they may need to reapply for permits if projects go unfinished for especially long periods of time.

Stalled home improvement projects can be a nightmare. But homeowners can address such delays in various ways to get projects back on track.

IMPROVE PRIVACY & SECURITY AT HOME

Living in close proximity to one's neighbors has its benefits. But many homeowners would no doubt admit that privacy at home is a good thing.

CONSULTATION – TAXATION OF CANNABIS

Submitted by Jim Eglinski, MP – Yellowhead

Jim Eglinski, Member of Parliament for Yellowhead, would like to inform residents that the Department of Finance has launched a consultation on a set of technical draft regulatory and legislative proposals under the Excise Act, 2001 that would provide for the additional excise duty rates for each province or territory that has signed a CCTA with the Government of Canada. These rates would come into ef-

fect when cannabis for non-medical purposes becomes available for legal retail sale.

In keeping with the agreement reached by Finance Ministers, under the CCTAs, revenues from the excise duties on cannabis products will be shared on the following basis: 75 per cent to provincial and territorial governments, and 25 per cent to the federal government. Provinces and territories will work with municipalities according to shared responsibilities towards legalization.

In addition, federal revenues from the excise duty on cannabis will be capped at \$100 million per year for the 24 months that follow the legalization of non-medical cannabis. Excess federal revenues over the \$100 million cap will be provided to provinces and territories that have concluded a CCTA with the federal government.

This consultation seeks comments on additional regulatory proposals that would provide:

- exemptions for certain entities to allow the possession of

cannabis products stamped for multiple jurisdictions, under certain conditions;

- the ability for third parties to possess cannabis excise stamps for specific purposes; and
- exemptions from the proposed excise duty for certain cannabis-based products that are not intended for human consumption.

Canadians are invited to provide comments on the draft regulatory and legislative proposals detailed below by October 17, 2018. Comments can be sent to: fin.cannabis-duty.2018.droit-cannabis.fin@canada.ca.



5 REASONS NOT TO RIDE YOUR OHV IN NATURAL AREAS

As leaves turn to their fall colours and crops are being removed from the fields, it's a great time of year for those who love to ride through the countryside on their quad or other Off-Highway Vehicle (OHV). And snowmobilers are itching for the right amount of snow for their chance to head out, too.

With the weather constantly changing, and with limited areas to go, it is highly tempting to ride into special areas, where environmental protection is the prime mandate, and OHVs are not allowed. Regardless of vehicle choice, a quad, snowmobile, other OHV or even mountain bike, it is essential to know where you can and cannot ride.

Trespassing on natural areas oc-

curs frequently on Edmonton and Area Land Trust (EALT) lands, despite clearly marked signs stating OHVs are not allowed. Such riders tend to come in from neighbouring trails and drive right past the signed rules, in other words, they feel they are above the law.

EALT does not make up rules to ruin your fun; in fact, many local municipalities have similar rules. Leduc County, for example, does not allow OHVs to ride in Environmental Reserves, which is the official designation of EALT's Coates Conservation Lands. It is also illegal throughout the Province, to cross a waterbody except at a developed crossing. So why should you care? There are many reasons why you should not drive OHVs in natural areas.

1) Protect drinking water

Like the Coates Conservation Lands, many other natural areas owned by EALT or by the municipality or province, contain

sensitive riparian habitat, which includes transition zones between water and land. Riparian areas acts as enormous water filters, cleaning runoff from the land. Willow Creek, and many other small creeks, flow into the North Saskatchewan River, and provide drinking water to well over a million people in the greater Edmonton region. Staying out of riparian areas on your OHV helps protect our drinking water.

2) Protect fish habitat

Many fish species, some of which are popular for fishing, spawn in shallow tributaries of the North Saskatchewan, like Willow Creek. Riding an OHV in a riparian area damages fish spawning habitat, as well as their eggs. Not only does this reduce the number of fish for sport, but also disrupts food cycles for other wildlife, such as herons and other large birds that eat fish.

3) Prevent erosion

Keeping OHVs off EALT lands (and government natural areas) will help prevent erosion. Deep ruts scar steep slopes, leaving soil exposed and increasing the erosion, as rain and spring runoff wash the soil down into the creek. Soil erosion increases sedimentation in the water, making it more difficult for fish and other wildlife

to survive in otherwise peaceful waters.

4) Prevent weed establishment

Riding in natural areas, especially riparian areas, allows weeds to spread. Seeds may cling to OHV tires or sides, and then spread to the next area that is visited. Weeds are particularly difficult to remove in riparian areas, and are also one of the leading causes of biodiversity loss across the world. Weeds can also be costly for crops, too.

5) Reduce risk of wildfires

While fall usually isn't a high-risk season for fires, the increasing number of wildfires in Alberta is another reason to be careful when riding your OHVs. The heat of OHVs can ignite dry debris that is caught in the machine or even on the ground. This debris can start a fire which would significantly reduce the area's environmental value.

Throughout Alberta, there are riding trails designated for OHV use. Be sure to plan your trip ahead

of time, determine where you can ride responsibly, follow all safety rules, and be respectful and ask permission if going on private land.

There are many myths about where one can ride OHVs. EALT's leaflet about the law and regulations related to OHVs clarifies these, and likely provides an eye-opener for many oblivious riders!

EALT Conservation Lands are open to the public to enjoy on foot.

EALT SECURES OLD GROWTH FOREST WEST OF EDMONTON

PARKLAND COUNTY AND EDMONTON, AB | September 21, 2018 – The Edmonton and Area Land Trust (EALT) is proud to announce it has secured 100 acres of old growth forest just west of Edmonton, in Parkland County.

This is the 11th conservation area secured by EALT in this, their 10th Anniversary Year.

The Land

This natural area is located a few kilometres west of Edmonton and a short distance from the North Saskatchewan River, and is adjacent to many other conserved natural areas. It is almost entirely undisturbed old growth forest and native understory shrubs, with patches of conifers nestled inside the mixed woods, and some of the spruce trees are around 100 years old, according

to the Northern Forestry Centre of Resources Canada.

The land is within one of Parkland County's Ecologically Significant Areas, and is adjacent to other protected areas with contiguous habitat, so it forms part of an important conservation corridor. There are several dugouts on the property, which have enriched the habitat even further. It provides excellent habitat for wetland and upland birds, mammals and other wildlife. Such wildlife include: moose, deer, great blue heron, great horned owl, Cooper's hawks, ruffed grouse, yellow bellied sapsucker, muskrat, and several songbirds including red-eyed vireos, purple martins and black-capped chickadees.

The land is part of a geologically significant post-glacial dune field, and has permeable sandy surface soils, so is part of a sensitive groundwater recharge area, which is important to Parkland County.

Conservation Easement

The landowner wanted to preserve the land's conservation values. So they did this by working with EALT to place a protective notation (a Conservation Easement) on Provincial Title. This restricts future activities which they knew would damage the native habitat, such as subdivision, development, logging, or drainage.

The EALT will now be monitoring the land in perpetuity, to uphold the conservation values, and to ensure that future owners don't engage in prohibited activities. Thus the Conservation Easement helps conserve and sustain Alberta's important biodiversity.

Quote:

"Conserving this land is important, as Edmonton's region is one of the fastest-growing areas in Canada, and our natural areas are disappearing far faster than we can conserve them. EALT is proud to contribute to the con-

servation of some of the last unspoiled forest in the Edmonton Region. This special landscape is part of the half percent of Alberta left in native aspen parkland. And besides being important in its own right, with trees over 100 years old and habitat for a large variety of wildlife, it's also part of a series of protected areas which form an important conservation corridor". - Pam Wight, Executive Director, Edmonton and Area Land Trust

About

The Edmonton and Area Land Trust is the only non-profit conservancy to focus entirely on conserving natural areas in and around the City of Edmonton. EALT has conserved 2,170 acres in 11 conservation lands over the last decade, and is working to secure more.

The Government of Alberta created the Alberta Land Trust Grant program which assisted with this securement.


