WARNING - SCAMS USING CBSA CREDENTIALS

The Canada Border Services Agency (CBSA) is warning the public about ongoing email, text messages or telephone scams in which people posing as officials from the CBSA are asking for personal information, including Social Insurance Number (SIN). The methods used by the scammers to communicate with the public, and the rational provided to justify be-

ing in contact with the victim, are varied, ever changing, but always designed to lure the public into providing personal information.

In some cases, these scams use false CBSA information. Telephone calls may display numbers and employee names that appear to be from the CBSA. Emails may contain CBSA logos, email addresses or employee names and titles to mislead the readers.

It is important to note that the CBSA never initiates a request for

social insurance number and credit card number by telephone or email. If an individual receives a telephone call or an email asking for this information, or requesting payments from the CBSA, it is a scam.

It is important to be vigilant. These calls or emails should be ignored and reported to appropriate authorities. If you have received this type of call, please report it to the Canadian Anti-Fraud Centre.

CANADA TRAINING BENEFIT

OTTAWA: Jim Eglinski, Member of Parliament for Yellowhead, wishes to inform constituents that the Department of Employment, Workforce Development and Labour, today announced a new Canada Training Benefit that will give Canadians the support and security they need to advance their careers.

Canada Training Benefit, a new measure that would give Canadian workers a tax credit to help pay for training, provide income support during training and offer job protection. The benefit would include:

- a \$250 per year, non-taxable Canada Training Credit, up to a lifetime limit of \$5,000, to help eligible workers cover tuition and training-related costs;
- a new Employment Insurance (EI) Training Support Benefit to provide income support when

an individual requires time off work to train;

- new leave provisions under the Canada Labour Code that would allow federally regulated workers to take time away from work to pursue training; and
- an EI Premium Rebate for Small Businesses to help offset the upward pressure on EI premiums.

Over the spring, the Government will engage stakeholders, including provinces and territories, on the final design of the EI Training Support Benefit and associated leave provisions.

"The new Canada Training Benefit will give Canadians the support and security they need to advance their careers," concluded MP Eglinski.

STRENGTHENING THE MIDDLE-CLASS BY PUTTING MORE MONEY IN THE POCKETS OF CANADIANS

Helping hard-working middle-class families provide the best start in life for their children is a top priority for the Government of Canada. That is why three years ago the Government launched the Canada Child Benefit (CCB) to help families with the high cost of raising kids.

In July 2018, the CCB was increased to keep up with the cost of living. This change came two years ahead of schedule to give parents even more money each month to help them provide for their children. The CCB—which is targeted to middle-class families and the people working hard to join the middle class—is simple, tax free and provides more money to 9 out of 10 families than previous child benefit programs.

On July 10, the Honourable Jean-

Yves Duclos, Minister of Families, Children and Social Development, announced that starting in ten days—on July 20, 2019—the CCB will be raised once again to keep up with the cost of living. This means that for the 2019–20 benefit year, the maximum benefit will be \$6,639 per child under age 6 and \$5,602 per child aged 6 through 17.

As an example, a single parent with two children under the age of 6 and an income of \$30,000 will receive an additional \$286 for the upcoming benefit year to keep up with the cost of raising their children. This means up to \$13,278 in support every year.

As another example, a child born today, over the course of 18 years, will receive \$49,157 more than before the CCB - based on \$50,000 annual family income. The same family can also access an additional \$1,547 thanks to the 5 extra weeks of Employment Insurance Benefits.

As a result of these changes, a child born in 2019 will receive almost \$51,000 more.

Thanks to the CCB, 9 out of 10 Canadian families have more money to help pay for things such as healthy food, sports programs and music lessons. Increasing the CCB will ensure that it continues to play a vital role in supporting families.

Quick Facts

- Across Canada, CCB payments worth \$23.7 billion benefit nearly 3.7 million Canadians and their families.

- More than 870,000 families in Quebec received nearly \$5.5 billion from the CCB in the 2017–18 benefit year.

- The CCB has had a positive impact on families' incomes, playing a key role in reducing child poverty. There were 278,000 fewer children living in poverty in 2017 than there were in 2015.

- The Canada Child Benefit and new initiatives like the Canada Workers Benefit and the Canada Housing Benefit will continue to help the middle class and grow the economy by putting money in the pockets of Canadians.

- The CCB has been recognized by the International Monetary Fund, the Bank of Canada and other experts as a key contributor to helping strengthen Canada's middle class.

- Examples of the new indexation rates for the 2019-20 benefit year:

- A single-parent family with one child aged under the age of 6 and earning \$25,000 will receive an additional \$143 for the upcoming benefit year. Bringing their new yearly total to \$6,639.

- A two-parent family with two children aged 4 and 9 and earning \$55,000 will receive an additional \$354 for the upcoming benefit year. Bringing their new yearly total to \$9,017.

- A two-parent family with two children under the age of 6 and earning \$90,000 will receive an additional \$263 for the upcoming benefit year. Bringing their new yearly total to \$7,090.

INDIVIDUALS CONVICTED OF SIMPLE POSSESSION OF CANNABIS CAN NOW APPLY FOR NO-FEE, EXPEDITED PARDONS

MONTREAL, Aug. 1, 2019 / CNW/ - Starting today, people who have a criminal record only for simple possession of cannabis can apply for a pardon, which will make it easier to work, go to school, travel and actively partici-

pate in their communities.

The Minister of Justice and Attorney General of Canada, the Honourable David Lametti, on behalf of the Minister of Public Safety and Emergency Preparedness, the Honourable Ralph Goodale, today announced the coming into force of an Act to provide no-cost, expedited record suspensions for simple possession of cannabis.

"Starting today, individuals who were disproportionately impacted by cannabis laws of the past, including visible minorities, Indigenous people, and those in our most vulnerable neighbourhoods can finally shed the burden and stigma of that criminal record and have the ability to move forward positively in their lives." - The Honourable Ralph Goodale, Minister of Public Safety and Emergency Preparedness

Individuals convicted only of simple possession of cannabis can now apply to the Parole Board of Canada (PBC) for a pardon through a streamlined, simplified process. The \$631 fee and waiting periods associated with other pardon applications are eliminated. Applicants will be eligible even if they have outstanding fines or surcharges associated with their conviction, as long as they have completed the rest of their sentence.

"Providing free, immediate access to pardons will allow those with criminal records for simple

possession of cannabis to move forward with their lives, making it easier to get a job, an education, rent an apartment or volunteer in their community. This is particularly significant for marginalized communities in Canada, who have been disproportionately impacted by the enforcement of previous cannabis laws." - The Honourable David Lametti, Minister of Justice and Attorney General of Canada

To assist applicants, PBC has put in place a streamlined Cannabis Record Suspension Application Guide and forms with step-by-step instructions, as well as a toll-free information line and email address to answer questions. PBC is working with partners, including police, courts, community organizations and criminal justice professionals to maximize the positive impact of this new relief. ALBERTA RCMP FOCUS AUGUST ENFORCEMENT EFFORTS ON DISTRACTED DRIVING

During the 2018 Heritage Day long weekend, there were eight fatalities and 39 injuries as a result of motor vehicle collisions in Alberta RCMP jurisdictions.

"We remind Albertans that distracted driving can severely limit

a driver's ability to focus on driving and road conditions," says Supt. Rick Gardner, Alberta Traffic Sheriffs. "Make sure to always put electronics away and to be prepared for unexpected actions of other road users and changing driving conditions such as construction."

The process for considering statements of opposition will be as follows:

- Previous detailed route decisions, including conditions imposed by the Board, will stand if no statement of opposition is filed in relation to them within thirty (30) days following the publication of this notice. Accordingly, no action on the part of a landowner is required to ensure that Trans Mountain continues to be bound by the conditions in the original detailed route decisions.
- If a written statement of opposition is filed with the Board within thirty (30) days following the publication of this notice, the statement relates to a previous detailed route decision, and the statement raises concerns regarding a material change in circumstances from the original detailed route process, the Board will conduct a review of the previous detailed route decision.
- For detailed route hearings that were in progress on August 30, 2018 and no decision was issued, landowners and Indigenous communities need to register their continued objection by filing a statement of opposition within thirty (30) days following the publication of this notice. The Board will then continue the hearing and may add new process steps, as necessary, to address any valid concerns with respect to changed circumstances.
- Landowners and Indigenous communities that did not file a statement of opposition in the previous detailed route process, whose statement of opposition was rejected or that withdrew their statement of opposition prior to a detailed route hearing, may file a new

statement of opposition within thirty (30) days following the publication of this notice. The Board may fix such amount as it deems reasonable in respect of the actual costs reasonably incurred by any person who makes representations to the Board at such a public hearing, and the amount so fixed will be paid forthwith to the person by Trans Mountain.

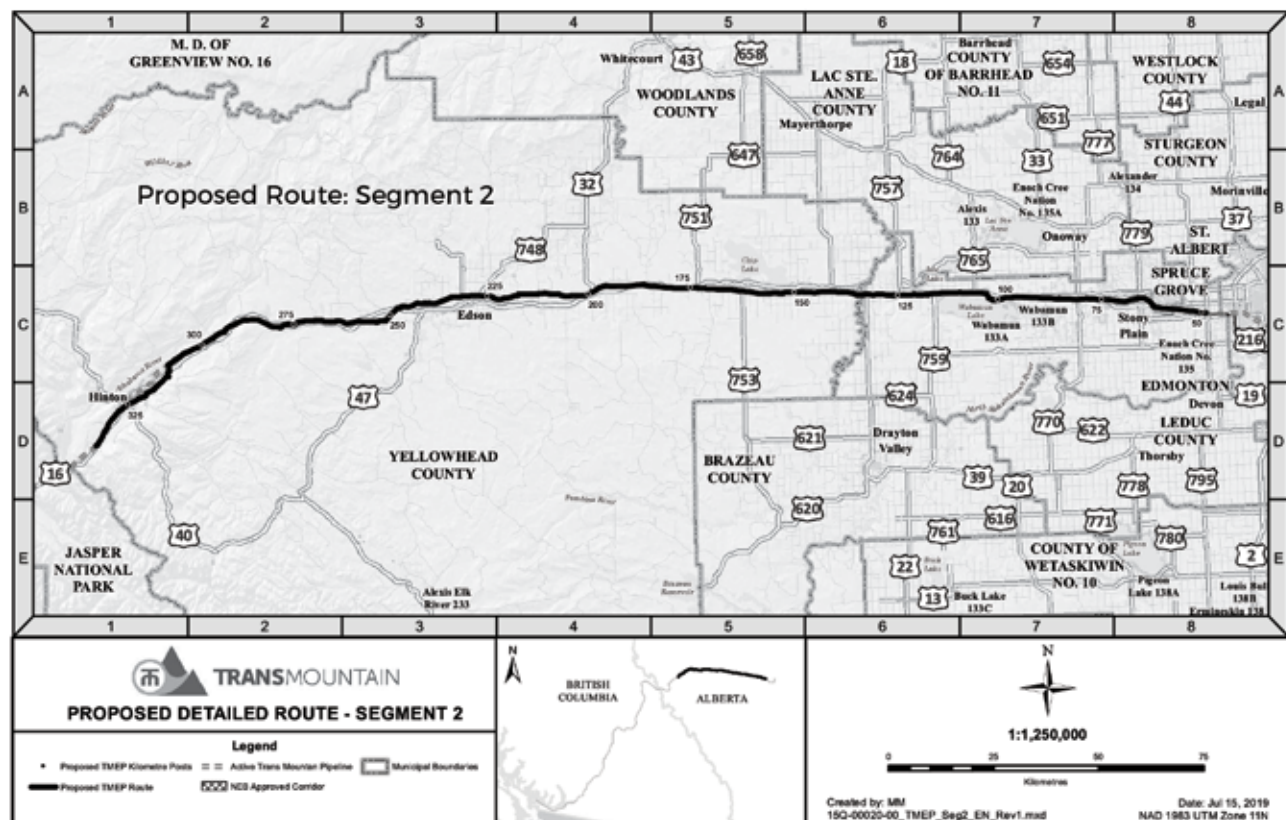

CONTRACT AWARDED FOR THE REDEVELOPMENT OF WHISTLERS CAMPGROUND IN JASPER NATIONAL PARK

50 Amp service.

DEADLINE EXTENDED FOR FARM AND SCHOOL DRIVERS

Alberta is extending the deadline for farmers and school bus drivers to meet training requirements as new commercial drivers. Farmers and farm workers can apply for an extension to meet the training and testing requirements for a Class 1 driver's licence before March 1, 2021. New school bus drivers will have until July 31, 2020 to meet the requirements for a Class 2 driver's

licence.

"The school bus driver and farming industries are highly flexible, seasonal industries that indicated they need more time to adjust to the MELT requirements. Our government is committed to taking steps to work with farmers and school bus drivers to ensure we have a robust driver training system in place that works for industry, without compromising safety. This extension ensures these key industries can continue their work without disruption, particularly during the

busy back-to-school and harvest seasons." - Ric McIver, Minister of Transportation

Quick facts

- Alberta introduced Mandatory Entry-Level Training (MELT) requirements for drivers seeking Class 1 and Class 2 commercial licences on March 1, 2019.

- Eligible farmers and farm workers can apply to Alberta Transportation for the MELT deadline extension until Nov. 30, 2020, while eligible school bus drivers can apply until July 31, 2020.

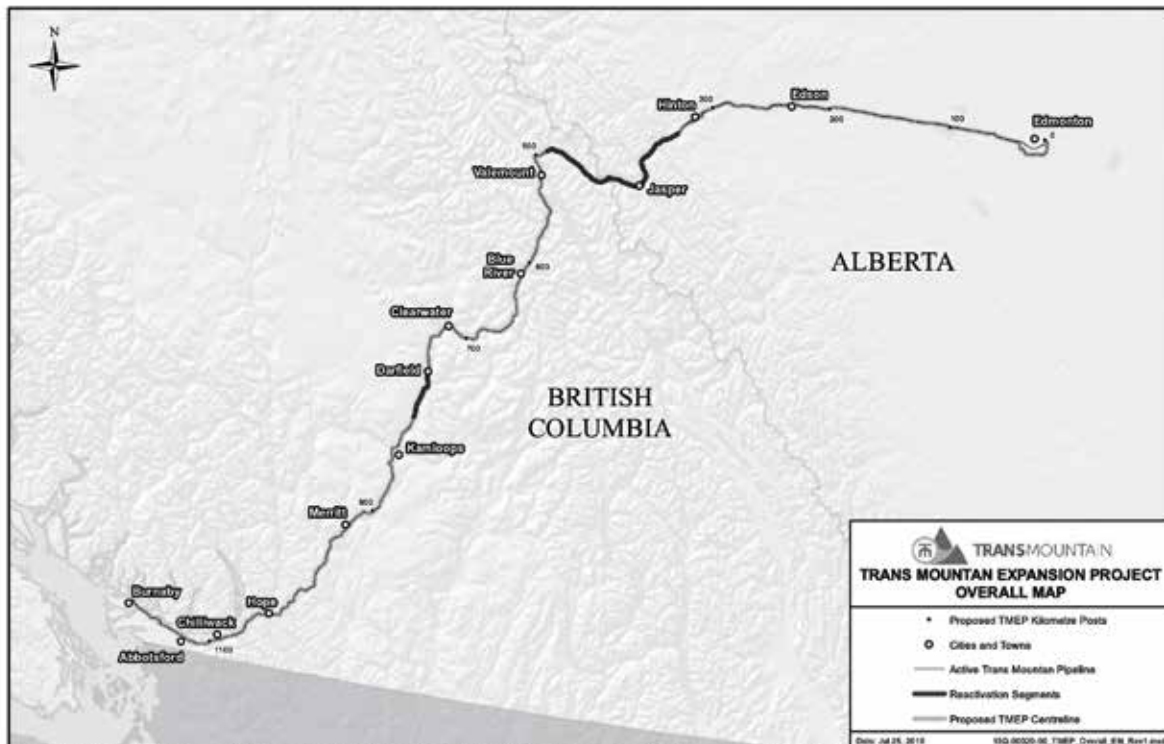
- Farmers and farm workers must pass the Class 1 enhanced knowledge and road tests that are based on the MELT curriculum before March 1, 2021 to keep their commercial licence.

- School bus drivers must pass the Class 2 MELT enhanced tests by July 31, 2020.

- School bus drivers who do not have an S Endorsement on their driver's licence will have until July 31, 2020 to complete the School Bus Driver Improvement Program.

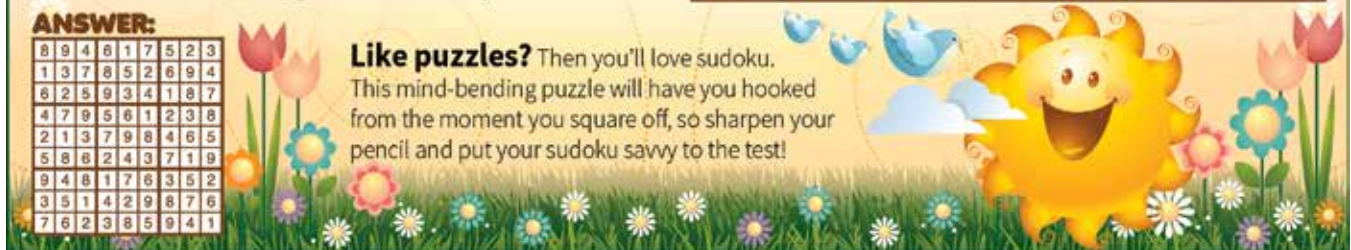
