## VEHICLES FALLING THROUGH THIN ICE ON WABAMUN LAKE

Parkland RCMP have recently responded to two separate incidents of vehicles falling through thin ice on Wabamun Lake in the last couple of days.

The first incident was reported on January 30, 2021 at about 2:40 pm where a truck had broken through the ice. The driver and seven passengers were able to get out of the truck in time before the truck sank into the lake. There were no injuries in this case. The second incident happened on January 31, 2021 at about 9:50 am where a truck broke through the thin ice. The two occupants in the vehicle were able to get out of the vehicle before it went further into the lake. No one was injured in this case either.

With the warmer than usual weather this winter coupled with the water conditions in Wabamun Lake, the ice has remained thin with some areas not freezing over at all. This increases the risk of being on thin ice in these areas, and falling through.

In both recent cases, everyone was lucky to get out of their vehicle in time. It should also be noted that the owner of the vehicle will be responsible for all costs associated with recovering the vehicle in addition to any environmental remediation costs as a result of vehicle fluids entering the water system.

# EVANSBURG MULTI-FAMILY RESIDENTIAL FIRE

On Jan. 26, 2021, shortly after 3 a.m., an Evansburg RCMP officer was patrolling in Evansburg and noticed a multi-family residential duplex on fire in the area of 49 street and 52 avenue.

The Evansburg RCMP officer attended to assist and notified the Yellowhead County Fire Department who attended. The Evansburg RCMP officer evacuated two elderly occupants;

The fire was eventually extinguished at approximately 9 a.m. and Evansburg RCMP, along with RCMP Forensic Identification Services and an investigator for the Alberta Office of the Fire Commission were on scene conducting an investigation.



# YELLOWHEAD COUNTY COUNCIL HIGHLIGHTS

#### Submitted by Yellowhead County

Universal Broadband Fund Partnership - Council approved a partnership with Nova/Rock, 3CIS, and Morad Communications with the intention to apply for a federal grant program known as the Universal Broadband Fund. A municipality must enter into a partnership with dedicated broadband service providers before applying for this grant. The grant will allow Yellowhead County to work with our partners to expand broadband and cellular services throughout the region-particularly in areas with lackluster service/internet.

Robb Tower Build Site - Yellowhead County has embarked on a project to improve broadband and cellular coverage throughout the region. To date, 10 towers have been built throughout the county. The next tower, designate YH-19, will be built in Robb. Council was presented with 13 site choices for the new build and approved site six for the tower build (just east of Robb). Electronic Signature Pol-



icy No. 1200.20 – The demand for digital document verification through signatures has increased in recent history. County administration proposes streamlining the document authentication process by allowing electronic signing. Notably, electronic signatures cannot be used in documents pertaining to estates, land titles/transfers, affidavits, loan documents, guarantees or negotiable securities and corporate registry items. Council adopted Policy No. 1200.20, Acceptance and Use of Electronic Signatures.

Property Tax Auction Results – On January 18, 2021 administration held the 2020 Property Tax Auction. Five properties were listed for sale, with two persons attending the auction. A bid of \$110,000 (plus GST) was offered for one of the properties and met the advertised reserve bid price. Council approved the final sale of said property. Council also approved the transfer of the four unsold property titles under Yellowhead County's name, to be marked as Tax Forfeiture.

# **HIGH SPEED** INTERNET

#### Submitted by Gerald Soroka, MP for Yellowhead

Gerald Soroka, Member of Parliament for Yellowhead, rose in the House of Commons to question the Minister on holding providers accountable in ensuring spectrum deployment in rural communities.

MP Soroka stated: "Mr. Speaker, for many rural Canadians, including thousands in my riding, wireless high-speed Internet is the only broadband solution available. Internet in my riding is offered to constituents at speeds of zero megabytes and up. However, with access to more spectrum, they could receive 50 megabytes download and 10 megabytes upload.

When the government is auctioning spectrum, what is it doing to hold providers accountable to ensure they deplov spectrum in rural communities?"

Hon. Maryam Monsef (Minister for Women and Gender Equality and Rural Economic Development, Lib.) replied: "Mr. Speaker, I thank my colleague for his important advocacy both with spectrum auctions and subsidies for those communities where the business case to connect households to high-speed Internet simply is not there.

Our government is there. Spectrum auctions include a carve-out for smaller rural communities. We have worked diligently to ensure smaller Internet service providers receive at least a third of our investment, the other third has gone to indigenous communities and that last third goes to larger ISPs.

If my colleague wants to connect to talk about how we can support his community in getting connected, my team and I are always here for him."



# DOS AND DON'TS OF CARING FOR WEDDING AND ENGAGEMENT RINGS

Jewelry is a key component of weddings. The financial resource CreditDonkey notes that, in the United States, the average amount spent on an engagement ring is \$5,500, while Canadians spend an average of \$3,500. Jewelry costs can add up, especially when adding in the cost of wedding bands, which can cost as much as \$1,000. The cost of jewelry only underscores the importance of learning how to care for it and preserve its value.

The best way to maintain jewelry depends on the makeup of the rings. The online jewelry guide Jewelry Notes says gold rings without gemstones can be cleaned effectively with only soap and water. Simply prepare a solution of lukewarm water and mild dish soap in a small bowl. Soak the rings for 20 to 30 minutes. Use a soft brush or cloth to clean the jewelry of dirt. Rinse the residue under clean water.

Rings with diamonds can be treated similarly with a mild soapand-water solution. The Diamond Information Center also says to soak the diamond ring in equal parts cold water and ammonia for half an hour and let it air dry. Brand name jewelry cleaner also is another good option. This method only should be used with diamonds; ammonia can't be used with other gemstones.


Maintaining jewelry also should include twice yearly visits to a jeweler who can check the prongs and make sure the setting is not loose; otherwise, the diamond can become dislodged, according to Martha Stewart

#### Weddings.

Avoid touching diamonds and other gemstones as much as possible when putting rings on and taking them off. Precious stones often are magnets for dust, dirt and body oil, according to Taylor Lanore, diamond consultant and engagement ring designer for Lauren B. Fine Jewelry and Diamonds. Grab the ring by the band.

Use discretion when wearing rings while engaging in hands-on activities. Activities like cleaning dishes, moving furniture, gardening, or diving through waves at the beach warrant caution; otherwise, you risk damaging or making jewelry unnecessarily dirty. Store the ring in a safe location until you can safely wear it again. One of the most important steps to safeguard wedding and engagement rings is to insure the jewelry. The description of the ring, its cut, carat weight, metal, and other information offered through a certified independent jewelry appraisal will be needed to insure the ring. Take a close-up photo of the jewelry as well. Other items like laser inscription or a home security system can qualify jewelry owners for discounts on insurance. Consumers also can add a jewelry rider to a homeowner's or renter's insurance policy.

These are some ways to care for wedding jewelry. Always consult with a jeweler before attempting to clean items made of various materials.

Various components combine to make weddings beautiful and memorable. Couples rely on photographers to capture the smiles and moments that helped make their events unique and to ensure the big day is remembered for years to come.

Will photos be color balanced and retouched? Skilled photographers are capable of capturing winning photos. But photos can be enhanced further in the studio with retouching software to bring out specific effects. Some photographers will polish all proofs, while others only will work on the images ultimately ordered. Confirm retouching details before signing the contract.

What's included in the photo packages? A detailed price list helps you compare one photographer to another and decide which elements are covered. Additional prints, having a photographer's assistant, ordering albums for the parents, or ordering a large framed print can alter costs significantly. Explore all prices to ensure you're getting the best value. In addition, consider how many hours of event coverage are included in the price.

What is the payment timeline? Photographers may accept deposits for their services but expect a different timeline of payment. Some may require payment in full before the wedding, while others may offer a payment plan that includes a final payment when picking up proofs or albums.

Wedding photography is one of the essential elements of a wedding and helps tell the story of couples' special day. Asking key questions can help couples find a photographer who will produce the desired results.

# MORE HEALTH MEASURES WILL EASE

Additional health measures will be eased for restaurants, indoor fitness and some children's activities, effective Feb. 8.

#### Submitted by Government of Alberta

Step 1 of Alberta's fourstep framework to ease restrictions is based on a COVID-19 hospitalization benchmark of 600, including intensive care patients. This benchmark was reached on Jan. 28.

The full, four-step framework for easing restrictions can be viewed here.

Indoor and outdoor children's sport and performance

Children's sport and performance activities are permitted if they are related to school activities, such as physical education classes.
This will allow K-12 schools and post-secondary institutions to use offsite facilities to support curriculum-related educational activities. Indoor fitness

• Only one-on-one training is permitted for indoor fitness activities (e.g. fitness in dance studios, training figure skating on ice, oneon-one lessons).

• One-on-one sessions cannot interact with others and there must be a minimum of three metres distance between sessions in the same facility.

• Sessions have to be scheduled or by appointment.

• No drop-in for individuals or groups is allowed.

• No sports games, competitions, team practice, league play or group exercise of any kind.

• Trainers must be professional, certified and/or paid trainers who are providing active instruction and correction. Passive supervision of a physical activity is not considered training.

• Trainers should remain masked during the session; clients are not required to wear a mask while exercising.

• More than one trainer and client 'pair' are allowed into the facility, studio, rink, court, pool, ice surface, etc., as long as:

- Each trainer and client stays three metres away from all other trainers and clients at all times, including in entryways and exits.

- Each trainer only interacts with their assigned client, and each client only interacts with their assigned trainer.

- No interaction between clients or between trainers is allowed.

- No 'cycling through' multiple trainers, as in circuit training.

Restaurants, cafes and

pubs

• Restaurants, cafes and pubs must collect the contact information of one person from the dining party.

• Up to a maximum of six people per table; individuals must be from same household or the two close contacts for people living alone.

• Liquor service ends at 10 p.m.

• In-person dining must close by 11 p.m.

• No entertainment allowed (e.g., no VLTs, pool tables, live music, etc.)
