Our plan is moving Canada's economy from reliance to resilience, though some

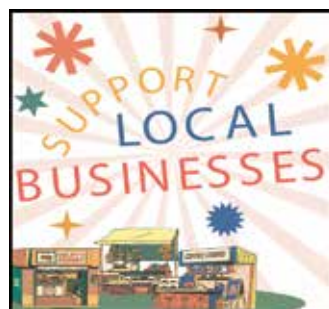

To build on that progress, the Prime Minister, Mark Carney, today introduced new measures to make groceries and other essentials

more affordable. To bring down your costs, Canada's new government is:

1. Putting more money back in Canadians' pockets

• The government is introducing the new Canada Groceries and Essentials Benefit – formerly the Goods and Services Tax

(GST) Credit. We are increasing its amount by 25% for five years beginning in July 2026.

• In addition to that, we are providing a one-time payment, equivalent to a 50% increase this year.

means that a family of four will receive up to \$1,890 this year, and about \$1,400 a year for the next four years; and a single person will receive up to \$950 this year, and about \$700 a year for the next four years.

•The new Canada Groceries and Essentials Benefit will provide additional, significant support for more than 12 million Canadians.

2.Tackling food insecurity, supporting producers, and strengthening supply chains

•The government is setting aside \$500 million from the Strategic Response Fund to help businesses address the costs of supply chain disruptions without passing those costs on to Canadians at the checkout line.

•For the same purpose, the government will create a \$150 million Food Security Fund under the existing Regional Tariff Response Initiative for small and medium enterprises and the organisations that support them.

•To lower the cost of food production, we are introducing immediate expensing for greenhouse buildings. This allows producers to fully write off greenhouses acquired on or after November 4, 2025, and that become available for use before 2030. This measure supports increased domestic supply and investment in food production over the medium-term.

•To ease immediate pressures with food banks, the government is providing \$20 million to the Local Food Infrastructure Fund. This supports food banks

and other national, regional, and local organisations to deliver more nutritious food to families in need.

•To tackle the root causes of food insecurity, we are developing a National Food Security Strategy – one that strengthens domestic food production and improves access to affordable, nutri-

tious food.

•This strategy will also include measures to implement unit price labelling and support the work of the Competition Bureau in monitoring and enforcing competition in the market, including food supply chains.

Our government is fo-

cused on building a stronger economy – to create more career opportunities and higher wages. In parallel, we are bringing down costs to make life more affordable. That's how we'll empower more Canadians with greater certainty, security, and prosperity – now, and into the future.

The Oneway Facility Enhancement Association (OFEA), would like to Thank everyone who supported us over the years as we worked hard to keep the Oneway Community Hall up and running. Unfortunately, our time at the Community Hall has come to an end, and we will no longer be managing it for the Town.

OFEA was created after the Elks and The Royal Purple who built and maintained the hall for many years folded. At this point a group of volunteers formed a non-for-profit society called the OFEA in 1997. This society from then till present, have paid for all maintenance, inspections, upgrades and utilities to keep the facility open.

In 2019, there were rumours that the hall would be closed, but a New Executive and Board was elected, and the OFEA was able to lease the hall from the Town once again.

In the past 5 years, over \$100,000.00 was spent on upgrades, maintenance, inspections and utilities. This was accomplished through numerous fundraising events, rentals, working a Casino every 2.5 years, an annual recreation grant of \$5000.00 from the Town of Oneway (last 4 years), a matching government grant of \$28,000.00, and a few donations from businesses and groups in town.

After a meeting with the Town of Oneway representatives on Nov.17/25, to discuss the renewing of the lease, the OFEA Board on December 2/25 meeting, unanimously decided not to renew the lease and focus their efforts in supporting local organizations and projects within the Community, rather than paying for building upgrades, maintenance and utilities. Moneys that were spent on monthly maintenance, utility bills, etc. will be redirected to programs and events in the Community.

We will continue to raise funds for events such as The Kids Christmas Party, Kids Halloween, and the Seniors Tea, and possibly others if funds are available. We will apply for FCSS funding to help maximize event opportunities. We already started our New Year with a \$4000.00 donation to the Lac Ste Anne Food Bank East (Oneway).

The OFEA Board hopes that the Hall will continue to remain open for everyone to enjoy in the upcoming years. The Board can define the Community Hall as a labour of Love, to make it grow and the much needed upgrades. Change can be difficult, but sometimes necessary to make things better.

ALBERTA RCMP ISSUES 998 TICKETS OVER THE HOLIDAYS

From Dec. 24-31, 2025, the Alberta RCMP was busy conducting enhanced traffic safety enforcement throughout the province, resulting in 998 tickets being issued.

Of the 998 tickets issued, 242 were for speeding, 31 for distracted driving and 21 for seatbelt infractions.

As well, 121 drivers were removed from the roads for being impaired due to drugs and/or alcohol, including 80 Immediate Roadside Sanction (IRS) FAILs and 23

IRS WARNs.

Unfortunately, due to road-related incidents, there were 99 non-fatal injury collisions and six fatal collisions, resulting in seven fatalities.

"We are never happy to report fatal motor vehicle collisions," says Sgt. Dar-

rin Turnbull, Alberta RCMP Traffic. "Everyone should have been able to make it home safely for the holidays. I encourage everyone to look out for each other on the roads. If you suspect an impaired driver, call 911 immediately."

PARKLAND RCMP & PARKLAND RCMP CRIME REDUCTION UNIT ARREST MALE FOR FIREARMS OFFENCES

On Jan. 19, 2026; Parkland RCMP received a complaint that a male opened his driver's side door and pointed a handgun at a youth pedestrian, near Jennifer Heil Rd

and Tri Leisure Way. Police were notified that the suspect vehicle was a white GMC truck and that it had left the scene.

Through investigation, police were able to locate the vehicle at the same area where the incident had occurred, a few days later.

Police approached the vehicle and arrested the male without incident. Police seized an imitation firearm (a handgun style pellet gun) from the driver's door pocket inside the vehicle.

Dai Suki Ryan Giovanni Kootenay, (19), a resident of Spruce Grove, has been

charged with multiple firearms related offences.

Dai Suki Kootenay was taken before a Justice of the Peace and release with his next court appearance on Feb. 18, 2026 at the Alberta Court of Justice in St. Albert.

URBAN AGRICULTURE IS GROWING: BEEKEEPING AND HEN KEEPING TAKE FLIGHT IN STONY PLAIN

The Town of Stony Plain is excited to announce residents can now apply for urban beekeeping and hen keeping licences, bringing a little more buzz and cluck to the community.

Urban beekeeping and hen keeping are permitted under the Non-Domestic Animal By-law approved by Council on June 23, 2025, following community interest and a review of best practices from other municipalities. The bylaw establishes clear standards for training, mentorship, animal care, and community impact to support responsible small-scale urban agriculture.

Expanding urban agriculture reflects the Town's commitment to environmental responsibility, a key pillar of the 2025-2028 Strategic Plan. Beekeeping and hen keeping are also key actions from the Environmental Stewardship Strategy, which guides initiatives to protect local ecosystems and advance long-term sustainability goals.

"We've heard from residents who are eager to start beekeeping and hen keeping, and I'm excited to see their success," says Mayor William Choy. "Urban agriculture isn't just about food; it's about growing community. Keeping bees and hens helps create a healthier, more connected community by sharing knowledge, and supporting each other through sustainable practices."

Prospective keepers must complete relevant training and find an experienced mentor for at least their first year. Education and mentorship ensure new keepers are set up for success while safeguarding community interests and animal welfare. Applicants are also required to notify their neighbours before setting up their hives or coops.

Highlights

Beekeeping

- Maximum two hives per property
- Hives must meet location and care standards
- Keepers must follow best practices to support colony health and minimize impacts on neighbours

Hen keeping

- Minimum of two hens and a

maximum of six

- Coops must meet size, locations, cleanliness, and care standards
- No roosters

"By setting clear standards, the Town is empowering residents to act responsibly, respect their neighbours, promote animal welfare, and strengthen community well-being," says Mayor Choy.

"Urban agriculture opportunities like this spark curiosity and inspire lifelong learning," says Evan Joyes, Sustainability Planner. "Whether you're tending hens or managing hives, these activities help people learn about pollinators, sustainability, food production, and local food systems. It's a rewarding hobby that benefits the whole community."

FIRE PERMITS ARE REQUIRED YEAR-ROUND

Lac Ste. Anne County Fire Services would like to remind all residents that a valid Fire Permit is required year-round for any open burning within the boundaries of the County. This includes burning brush, debris, or any other combustible materials, regardless of the season or weather conditions.

The implementation of year-round fire permitting (quite a few years ago) has resulted in a significant reduction in spring holdover fires, which are often caused by unregulated winter burning. These fires can smoulder undetected beneath snow for weeks or even months, only to re-emerge in the spring when conditions become dry and windy—posing serious risk to property and public safety.

Obtaining a fire permit helps ensure burns are conducted safely, responsibly, and under appropriate conditions. County Fire Guardians can provide guidance on safe burning practices, weather considerations, and any current restrictions that may be in place.

Residents planning a burn are encouraged to contact their local Fire Guardian in advance to arrange a Fire Permit. There is no cost to obtain the permit. A list of Fire Guardians is available on the county's website, or residents may contact the County Administration directly for further information or assistance.

Working together, we can help prevent unnecessary fire risk and keep our communities safe year-round.

Completed registration forms must be submitted by 12:00 midnight on Saturday, January 31, 2026.

Once properly registered, all contractors working for the County must comply with safety requirements at all times while performing work on behalf of the County, including being equipped with approved reflective safety vests, hard hats, and CSA-approved steel-toed boots.

By registering with Lac Ste. Anne County, gravel truck and equipment owners agree to operate in a manner that reflects a professional partnership between the contractor, the County, and the community, with a focus on courtesy, efficiency, and safety.

HOT STREAK: ALBERTA SETS ALL-TIME HOUSING RECORD

Alberta is building homes faster than ever, shattering housing construction records for the second year in a row and driving down rents.

Alberta is getting shovels in the ground and roofs over Albertans' heads at record pace. In 2025, the province delivered a second record year for housing starts, breaking several all-time records along the way. For the first time in Alberta's history, more than 50,000 housing starts were reached in a single year, with more than 53,000 homes breaking ground in the past 12 months – 14 per cent higher than the previous record set in 2024.

Q2 2025 marked the strongest quarter for housing construction in provincial history, with more than 17,000 housing starts, eclipsing a record set almost 10 years ago.

"Once again, Alberta is punching above our weight. Our province is shattering housing records and building at unprecedented

rates, keeping pace as more people than ever before call our great province home."

Alberta is setting the pace for housing construction in Canada. For the second year in a row, the province led the country in housing starts per capita. Despite making up less than 12 per cent of Canada's population, Alberta built almost a quarter of housing starts across the country in 2025, and more than 80 per cent of all starts across the prairies.

These results show the province's plan is working. Alberta is slashing red tape through initiatives like the Stop Housing Delays portal, supporting innovative housing strategies and fostering an investment-friendly, low-tax environment that has incentivized housing construction provincewide as more people than ever before choose to call Alberta home. By removing barriers and enabling builders, Alberta has cemented its place as a heavyweight in the housing world.

This year also brought good news for renters, with rents in Alberta decreasing almost double the national average. As we enter 2025, Alberta's average asking rent is about \$400 per month below the national average, and outside of the larger cities, Alberta communities made up six out of the top 10 most affordable small- and mid-size rental markets in Canada, including taking all four of the top spots. Notably, the number of purpose-built rentals being developed in the province soared in 2025 to nearly 20,000 starts – almost triple the levels seen a decade ago.

ALBERTA WORKING TO ELIMINATE CERVICAL CANCER: TRANSITION TO HPV SCREENING

The cervical screening test is now being routinely offered to those aged 50 to 69 in Alberta to check for high-risk types of the human papillomavirus (HPV) that can cause cervical cancer.

The cervical screening test is the new standard for cervical cancer screening in the province. Cervical cancer is preventable and almost always caused by HPV. Scientific evidence indicates HPV testing is the more effective way to identify cervical cancer, and many provinces and territories are already transitioning to this approach instead of pap tests for routine cervical screening.

HPV infections are common and usually do not cause symptoms, so most people do not know they have it. A majority of HPV infections are cleared by the body. However, certain HPV types do not clear and can cause cell changes that can lead to cervical cancer.

"By testing for high-risk HPV types that cause cervical cancer, patients who are at risk can be identified earlier and more accurately," says Dr. Carolyn O'Hara, Interim Chief Laboratory Officer, Alberta Precision Laboratories. "This change

strengthens the quality of cervical cancer screening across the province and supports better outcomes for patients through timely, evidence-based testing."

Planning is also underway to expand the cervical screening test to Albertans ages 25 to 49. This group is currently offered regular Pap tests, which check for abnormal cells in the cervix that can lead to cancer. Pap tests are recommended every three years, while the cervical cancer screening test is recommended every five years. Once the new cervical screening test has expanded to ages 25 to 49, Alberta will no longer offer routine Pap tests.

"Whether you're eligible for a Pap test or the cervical screening test, screening only takes a few minutes and can save lives. Getting screened regularly is the best way to find HPV or abnormal cervical cells early, before symptoms begin," says Dr. Jack Pang, Medical Lead, Alberta Cervical Cancer Screening Program. "This change reflects strong scientific evidence and supports the goal of eliminating cervical cancer while ensuring Albertans have access to high-quality cervical screening."

This cervical screening test was implemented in collabora-

tion between the Government of Alberta, Primary Care Alberta and Alberta Precision Laboratories.

"Alberta is proud to lead the way in adopting high-risk HPV testing as the new standard for cervical cancer screening. This transition reflects our commitment to evidence-based healthcare and ensures that Albertans receive the most accurate and timely screening available," Adriana LaGrange, Minister of Primary and Preventative Health Services. "By identifying those at risk earlier, we are taking a significant step toward eliminating cervical cancer and supporting the lifelong health of our communities."

The cervical screening test is done by a healthcare provider and only takes a few minutes. A sample is collected in the same way as a Pap test and sent to the lab for testing.

Contact your healthcare provider's office or a women's health clinic to book an appointment to get screened. If you do not have a healthcare provider, such as a family doctor or nurse practitioner:

- Visit Alberta Find a Doctor, or
- Use the screeningforlife.ca locator tool and select "cervical" as the type of test to find screening options near you, or
- Call Health Link at 811.

It's important to continue to get screened, even if:

- You feel healthy and have no symptoms of cervical cancer.
- You've only had one sexual partner.
- You've had the human papillomavirus (HPV) vaccine.
- You've been through menopause.
- You're no longer sexually active.

SWAN HILLS RCMP ON SCENE OF SERIOUS MOTOR VEHICLE COLLISION

On Jan. 20, 2026, around 4:20 p.m., Swan Hills RCMP, with assistance from Whitecourt RCMP and Whitecourt RCMP Traffic Unit, responded to a multi-vehicle collision on Highway 32 approximately 43 kilometres south of Swan Hills, near the Blue Ridge Haul Road. In total, 4 pickups, 2 semi-trucks and 1 sedan were involved in the collision.

Upon arrival, traffic control measures were implemented as the highway was fully blocked by vehicles and debris. RCMP, EMS and STARS were on scene, helping to extract several people, including a baby in a car seat and their mother, from various vehicles. Despite life-saving efforts by emergency crews, a 60-year-old male resident of Whitecourt, who was driving one of the pickups, was pronounced deceased on scene. Others involved in the collision

reported a varying degree of injuries, but none were life-threatening. The mother and baby were transported by STARS and are reported to be in stable condition.

An RCMP Collision Analyst attended the scene and, once the investigation was complete, the highway was cleared of vehicles and debris. The highway has since reopened. Though the investigation is ongoing, initial reports suggest that an initial collision between a pickup

truck and a semi-truck occurred due to sun glare which was causing low visibility and varying speeds. As the vehicles were attempting to pull aside, traffic behind slowed down but, once again due to sun glare, a semi-truck did not note the slowing traffic and collided into multiple vehicles.

The Alberta RCMP sends their condolences to the family and friends of the deceased.
